Council and Planning Board members are in agreement to accept the Agenda.

1. WA-058 Review

Gary Roberts

Gary leads a discussion on WA-058, Whitehall Village North DENSITY

• Current zoning of RS20 would allow 126 homes. Petitioner asking for change in zoning to allow 108 multifamily & 120 houses.

CONNECTIVITY

- 5' wide sidewalk to High School only (no street connection)
- County Planners recommend a street connect to Wickenham Rd. This would give both developments a second entrance/exit for First Responders in case of an accident at either of the Sullivantown Road entrances.
- County Planners recommend removing cul-de-sacs, then connect streets together
- Sidewalks on both sides of the streets (Town requires 1 side only)
- Crosswalks

TRAFFIC

- Traffic count under current RS20 zoning would be 1200 daily trips.
- Traffic count with change in zoning to include multifamily housing increases to 1800 trips per day.
- County Planners recommend \$100,000.00 bond for a traffic/streetlight study, if needed, at the Whitehall Village entrance on 66. The traffic count from Whitehall would have to increase significantly to warrant a traffic study.
- DOT makes the decision to add stop lights, not the Town of Walkertown.

FIRE SERVICE / EMT

Wesley: I have several concerns. First, with access. If there were an accident at the entrance off of Sullivantown Road, first responders would have to go to Esher Drive in Whitehall Village.

Also, the width of the street is 27 feet. With cars parked on the street there wouldn't be room for the ladder truck to extend outriggers.

The radius of the cul-de-sacs may be too small for firetrucks to turn around. Gary: I'll make sure Keystone is made aware of all concerns. Any other

concerns or questions?

OPEN SPACE

Peggy: Gary, please show us on the map:

- 15% Open Space
- Recreation areas
- Berms, plantings & setbacks

Gary: Staff recommends denial.

Scott: Thank you Gary, good job.
