### 5. COMMITTEE UPDATES

Scott: There was no TAC meeting. I included a COG calendar in the agenda. Peggy: The COG had a clean audit. Of the \$35 million budget, most went to grants. \$800K was administrative expenses.

14 counties now use the COG to oversee home repairs. (Home Consortium)

Scott: Our sweepstakes case went before the County Board of Adjustment. Lucky Star was granted a continuance.

Total expenses are at 30%. Revenue "in" at 29%, which is slow. Property tax

has finally moved forward to 28%. Interest coming in well.

Doc: Unrestricted Funds @ \$3,598,965.55 and Restricted Funds @ \$885,260.17 for a Grand Total Fund Balance of \$4,484,225.72.
