#### Management, Operations and Snack Bar

Operations had a good summer with the management team of Phil Hartman, Libby Ryan, and John Potts and we expect Phil to return next summer along with other managers. We also had many returning guards along with some new guards who will be with HFSC throughout the next few years, training to help in pool management. We made some changes to the lifeguard rotation, training and responsibilities and have been generally pleased with improvements in pool operations can pool cleanliness. We have some lessons learned from this summer that we will apply to next summer to further improve snack bar operations. Our swim team, lead by Mikell von Kolnitz, Michael Monaco, Joel DeSatnick and Isabella Ness completed a very competitive season and brought home the first place trophy for relay carnival. The dive team, with seasoned coaches George Perdue, David Garaffo and Kelly Kalkus moved up to the very competitive Division 2 and held strong against some very tough teams. Kudos to all of the coaches for doing a super job motivating our young swimmers and divers. Thanks to all the swimmers, divers & parents alike for cheering on your teammates (and other teams!), volunteering on deck, working hard, and showing good sportsmanship to officials and your competitors. #### Membership

The Hayfield pool continues to thrive in popularity. Our waiting list of families who want to become members of our pool is at a 4 year wait, with 57 families on it. We saw a drop in the number of shares sold or transferred this year which accounts for the increase in wait list time. Of the 425 pool shares, 117 shares were leased this season and we sold 33 additional Late Summer Passes. We are researching improvements to our check-in system and general computer setup for next season.

#### **Maintenance and Improvements**

Last off-season we continued the improvements to the facility by completely rebuilding the bottom of the baby pool. There was a drainage problem that had to be resolved. One diving board was completely replaced and the other was refurbished. The parking lot had new gravel spread and compacted. The video camera security system was updated with new cameras and recording DVR. The drinking fountain was replaced. We are considering other capital improvements as well, but we also have to continue to rebuild the reserve funds in anticipation of the next white-coat replacement, so we are in a good financial position next time it needs to be replaced.
