## **BUSINESS FOR DISCUSSION AND/OR ACTION:**

#### 1. PROJECTS UPDATES

Scott: No change in project let dates; Old Hollow Road – July 18, 2023 & Reidsville Road – December 19, 2023.

No move yet on ROW acquisition. However, appraisals are moving forward.

Doc: They are paying out funds for inconvenience of use.

Scott: Darrow Road / Hwy. 66 intersection: Still waiting on the costs for

amenities for poles etc.

Federal funds are coming to states. We will wait and see how they can be used.

Doc: They keep saying the Old Hollow Road project is from Harley Drive to Bellaire Circle. Once they started saying it that way, it is hard to get it changed.

Scott: That is a misprint on the report, I will let the MPO know it needs to be updated.

Doc: Thanks. The 66/158 intersection is most important.

Vernon: Why is 158/Darrow Road not a full access intersection?

Scott: I included Connie's email in the agenda. NCDOT states "we could make the directional left-over work".

Peggy: How does that work?

Scott: I'll have to contact NCDOT to clarify.

Doc: DOT doesn't want a full access intersection there.

Vernon: What avenue do we use to object?

Scott: Have residents call or email NCDOT-Connie James is the contact person.

#### 2022 PAVING

Scott: We are taking bids for paving projects through February 17<sup>th</sup>. The paving and patching project is for the town part of Harley Drive, Winthrop Street & Willoughby Street.

Maybe prices have stabilized. We hope to have finalized by February Town Council meeting.

#### SURPLUS TRUCK SALE

Scott: We are selling as surplus a 1987 International w/ snow blade & salt spreader.

10 day advertisement ends February 7.

We are still accepting offers.

SIDEWALK project is moving forward.

### 2. FINANCIAL STATEMENTS

January, 2022

Doc: We are 58% into the year. Every line well within budget. Ad Valorem at 82%. Sales Tax and Powell Bill revenue ahead.

Scott: Yes, the state has added money to Powell Bill revenue.

Doc: Thanks Scott. Overall Revenue at 67% and Total Expenses at 27%. Unrestricted Funds for January @ \$5,528,908.52 and Restricted Funds @\$958,603.25 for a Grand Total Fund Balance of \$6,487,511.77
