GENERAL INFORMATION

The junior golf program will be a six week instructional program. Classes in which eight (8) or less students sign up may be cancelled. Students that have signed up for cancelled sessions shall be given the opportunity to sign up for a class offered at a different day/time.

ABSENCE & MAKE-UP POLICY
