# MARSHALL DECKER WITH DECKER AND DEGOOD TO PRESENT ANNUAL AUDIT

Marshall with Decker and DeGood says his grandson passed the CPA test in April and will be taking over. First 2 pages are opinion pages. Everything is in the correct format. Modified cash means that you have fixed assets and long term debts. Highlights would be page 6 is profit and loss statement. Governmental funds is a different part of proprietary funds. We did a lot of major improvements for the year. What is left in the general fund is streets and capital improvements. Page 5 is a breakdown of capital improvements and streets.

Park is in good shape. In the final year of the Bond payment, the remaining money will be left to pay the balance and the rest would be transferred to general fund.

Sewer fund would like principal paid and interest paid. It's a little bit less than but we also collect impact fees. Sewer fund, cash flow is good, rates are good.

Rest of the information is accounting information that is required to be in the audit. Amortization schedule in there as well. Most of the debt looks like Revenue Bond and GO Bond. At the end, adjustments to the balance were made for the FEMA building. Budget was in compliance with state statute. Mayor found that Maintenance building isn't on the schedule but

that was before Marshall took over. It has already come out of general so it should be fine. If we ever sold it, it would show a net gain.

He would use the capital improvements fund before depleting the general funds. General fund is for administration, police, court, doing away with court will help a lot. No further questions.

#### POLICE DEPARTMENT

Chief Ewbank states that he has been working on a cloud system for camera footage and it's about \$4,800 if we contract for 3 years, \$4,320 for 5 years. Altec has outside point and refurbished is about \$300 and \$380 for new. There are other options if it doesn't work. The body cam would go on a device and straight into the cloud. That is Provision. Altec has some other ideas but not sure if it will work with Provision. You can set up permission so certain people have access to it. If it's marked as evidence it gets stored forever and if not it deletes in 6 months. There is a gentleman from Provision is coming by December 7<sup>th</sup>.

Veach asks if the Chief could save it even if the officer didn't think it was important enough to keep. Chief says yes.

Fully equipped vehicle was picked up today. The other will be delayed due to needing some antennas and power cable. They will be overnighted by Provision. The SOPs are being worked on. Had rifle range yesterday. Last one was done 3 years ago.

Danderson asks if that is a brand that we will stick with. Do we want to be tied to Provision? Would definitely consider that before being tied in for a 5 year term. Roe asks if this is the same as Springfield and Greene County. Ewbank says that County doesn't use body cams but Springfield does that. Danderson asks Lord if he has seen the paperwork. Lord says he would like to meet with the Provision guy. Ewbank says that he will be here December 7<sup>th</sup> at 10:30. Board is good with the \$150 access point.
