There being a quorum, Mayor Simmons called the meeting of the Vienna City Council to order at 6:50 p.m.

Alderman Myrick made a motion to approve the Omnibus Consent Agenda consisting of the May 2, 2018 City Council Meeting Minutes and the Warrant (\$93,053.03). Alderman Racey seconded the motion. Roll call: Hill-yes, Riddle-absent, Myrick- yes, Owen-absent, Racey-yes, and Tuey- yes. Motion carried.

NEW BUSINESS

Alderman Racey made a motion to Authorize and Approve the Zoning Board's decision from the May 14, 2018 hearing to rezone 129 Veteran's Avenue from Rural Agriculture to Commercial for development of rental homes. The motion was seconded by Alderman Tuey. Motion carried.

Alderman Racey made a motion to Authorize and Approve Ordinance No. 18-03, An Ordinance amending Section 35.15 (Fees for Fire Dept Response) of Chapter 35 (Finance) of Title III (Administration) of the Vienna Code of Ordinances. Alderman Myrick seconded the motion. Roll call: Hill-yes, Riddle-absent, Myrick- yes, Owen-absent, Racey-yes, and Tuey-(abstained as member of Fire Dept). Motion carried.

PUBLIC COMMENT

Jason Claunch, River to River Relay was present to speak with council of assisting with the timing of the City's first Color Run that is scheduled to take place Saturday September 22nd. Brief discussion of event took place.

CITY ELECTED AND APPOINTED OFFICIALS

Mayor Simmons briefly mentioned appointing two members to the zoning board at the June 6 meeting.

Clerk Wright informed council that the city's former auditor, Kemper CPA would not be performing the city's annual audit and she was awaiting response from several firms contacted. Wright also informed council that IDOT had received the request for street closures for the JCYL youth league parade June 9th and would be approving the request but had contacted her to change the wording as liability amounts needed increased. All council members were in consent to make the amendment necessary to Resolution 18-03.

City Supt Racey informed council that a heating, A/C Unit needed replaced at the lagoon building. Racey also made mention of electrical work needed around the city square for placement of Christmas lights.

Treasurer Meyer updated council of Spring Fling profit (\$415.00) to the Community Fund.

Phil Morris said donated railroad memorabilia was placed at the depot. Morris mentioned the 50/100 mile run to take place in November.

Librarian Mathis requested public works to assist with preparing the library lawn for the annual Memorial Day Service.

As there was no further business to discuss Alderman Tuey made a motion to adjourn seconded by Alderman Racey.

Mayor Simmons declared the meeting adjourned at 7:12 p.m.
