# **Fishing Regulations**

Don't forget to get your 2021 fishing license if you don't have a 65+ one. Also remember all general fishing regulations apply to Village lakes.

Arkansas Game & Fish made several changes to fishing regulations for 2021. Below are listed several of the changes that are noteworthy to our area.

## **Boat Plugs**

All boat plugs must be removed before leaving the loading area. All aquatic vessel drain plugs must be removed before and during transportation. Fishing tournament officials may submit a request for written permission to allow for the transport of fish to a weigh station

# **Lake Catherine (Hot Spring, Garland counties)**

Smallmouth bass must be released immediately.

## Lake DeGray (Clark, Hot Spring counties)

Largemouth bass must be 13 inches or longer to keep. Smallmouth bass must be 12 inches or longer to keep. Largemouth, smallmouth and spotted bass combined daily limit is 6 (only 2 of which may be smallmouth bass). In addition to the combined daily bass limit, 10 spotted bass may be taken.

# Lake Greeson (Pike County)

Smallmouth bass must be 12 inches or longer to keep. Largemouth, smallmouth and spotted bass combined daily limit is 10 (only 2 of which may be smallmouth bass). In addition to the combined daily bass limit, 10 spotted bass may be taken.

# Lake Ouachita (Montgomery, Garland counties)

Largemouth bass must be at least 13 inches or longer to keep. Largemouth, smallmouth and spotted bass combined daily limit is 6 (only 4 of which may be smallmouth bass). In addition to the combined daily bass limit, 10 spotted bass may be taken.
