#### New Mexico – Exam Requirement and Fee Update

Effective July 01, 2021, New Mexico will change the time allowed for renewing a discontinued license without being required to re-take the qualifying examination, from within 5 years of the discontinuance to within 1 year of the discontinuance, unless the previous license was suspended or revoked, or continuation was refused by the superintendent. In addition, there will be fee updates for Resident Licensing, Resident Licensing Renewal, Non-Resident Licensing, Non-Resident Adjuster Licensing, Non-Resident Adjuster Renewal, No Home State Licensing, and No Home State Renewal products.

Temporary Producer is also being removed from the Non-Resident Licensing Gateway products. Please review the below tables for more information.
