Possession will be given at the time of closing upon delivery of a merchantable abstract and deed. The current real estate taxes will be pro rated to the date of closing. Although none are expected, for parcels requiring survey, the 10% down payment required will be based on indicated acres. The final sales price will be adjusted according to final surveys.
