

**HAMPTON TOWNSHIP  
ORDINANCE #2012-04**

**AN ORDINANCE APPROPRIATING THE SUM OF \$8,000.00  
CURRENTLY LOCATED IN THE CAPITAL IMPROVEMENT FUND  
FOR INSTALLATION OF ADA DOORS**

**WHEREAS**, there is currently an amount in the Capital Improvement Fund for the purpose of installing ADA Doors at the Municipal Building; and

**WHEREAS**, the County of Sussex has made available through a grant the amount of \$6,575.00, and it is deemed appropriate that the remainder be funded from the Capital Improvement Fund for payment and installation of said doors.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Hampton, Sussex County and the State of New Jersey that there shall be appropriated the sum of \$8,000.00 from the Capital Improvement Fund as stated above.

**SECTION 1.** There is hereby appropriated from the Capital Improvement Fund the sum of \$8,000.00 for the installation of ADA doors.

**SECTION 2.** All Ordinances or parts of Ordinances, which are inconsistent with the terms of this Ordinance, be and the same are hereby repealed to the extent of their inconsistency.

**SECTION 3.** This ordinance shall take effect immediately upon proper passage and publication in accordance with law.
