
# Lincoln Electrical JATC 2018 Continuing Education Class Schedule

### **Electrical License Renewal Reminder:**

**NEBRASKA LICENSEES**: Your licenses expire December 31, 2018. You will need to earn a total of 12 (twelve) hours of approved continuing education by that date in order to renew. There is no grace period. You are required to take a minimum of 6 (six) hours of code in order to renew your license, but you may take all of your hours in the code if you prefer. We do submit course rosters, but you may also need to submit your certificate/s as part of your renewal documentation if your courses are at the end of the year.

You can check your Nebraska Continuing Education Hours at this link: <u>http://www.nebraska.gov/sed/search/cesearch.cgi</u> We are not aware of how often Nebraska Continuing Education hours are updated.

**IOWA LICENSEES**: Your licenses expire December 31, 2019. You will need to earn a total of 18 (eighteen) hours of approved continuing education by that date in order to renew. There is no grace period. You are required to take a minimum of 9 (nine) hours of code in order to renew your license, but you may take all of your hours in the code if you prefer. We submit course rosters for Iowa hours.
