| <ol style="list-style-type: none"> <li>1. Parade entries may only complete one complete lap of parade route.</li> <li>2. Riding on the top of or outside of vehicles without belts or harnesses is prohibited.</li> <li>3. Fire or open flame on any entrant is prohibited.</li> <li>4. All drivers of vehicles and floats shall possess a valid driver's license.</li> <li>5. Fire extinguishers rated 2A – 10BC are required on all motorized decorated vehicles.</li> <li>6. Exhaust system shall extend beyond any and all decorations so that drivers or riders are not exposed to carbon monoxide fumes.</li> <li>7. Compressed gases (such as helium) shall be properly secured and safeguarded.</li> </ol> | <ol style="list-style-type: none"> <li>8. All participants should maintain a distance of twenty-five (25) feet between one another to allow visibility of children and other participants running into the street.</li> <li>9. All decorative materials must be fire retardant.</li> <li>10. Parade entries unsafely operating vehicles or animals will be removed from parade and cited by the Othello Police Department.</li> <li>11. The City of Othello reserves the right to bar from the parade at any time any entrant not conforming to the rules or refusing to follow the instructions of the police or parade officials.</li> <li>12. Alcoholic beverages are prohibited on any float or vehicle or on the person of any participant.</li> </ol> |

### AGREEMENT TO INDEMNIFY

I/we also hereby individually and on behalf of my/our heirs, executors and assigns, release, indemnify, defend and hold harmless the Adams County Fair and Rodeo, its officials, employees, volunteers, agents, and the City of Othello, and waive any right of recovery that I/we might have to bring a claim or a lawsuit against the Adams County Fair and Rodeo organization and City of Othello for any personal injury, 2014 Adams County Fair and Rodeo Parade death or other consequences occurring out of my/our voluntary participation in this activity. This agreement is executed by the authorized representative of the respective organization and shall serve to bind all persons associated with the aforementioned parade unit.
