 - i. A tractor complete with brush hog was acquired from Charlie Ruth.
 - j. Thanks to Marsha for an excellent job decorating the Arlington Woods sign for Christmas-very tasteful!!
 - k. The flower beds in the front were in the best shape ever, thanks to Jan Neville and Jerry Cleland.

- Brad Hanna engaged as light maintenance person, the responsibilities to include purchase of globes, fixtures, and repairs where necessary.
- m. Mosquito control. Despite a less than optimal beginning due to Resemethrin, later in the year mosquito control was very effective with Permethrin. A vote of thanks to Greg Clair for doing the necessary research to get us on the right track and begin the establishment of a mosquito control program for Arlington Woods. Greg plans to train Brad Hanna Ed Cleland in the use of our fogger.
- n. City water! Probably will be in the Woods by spring or early summer of 1993. The exact route of the water line in the Woods is yet to be decided.
- o. Good relations with the Central Fire District has been established, and their assistance has been invaluable in burning brush accumulations from the clean-ups.
- p. Trees have been transplanted to nicely visible locations along the pond edges by Ed Cleland and Jim Graf. They are doing well.
- q. Donations have been made by the Woods Property Owners Association in the names of George Henry and Jim Pelton, both recently deceased. Our deepest sympathy are extended to the Henry and Pelton families.

V. New and ongoing projects.

- a. We will continue to work with the County on our problems with the middle branch of the Portage. It should be noted that the promised cleaning up of the segment from US 25 to the amtrack trestle has not yet materialized.
- b. Woods ditch clean-up. This has been an ongoing concern, and it is suggested that the new Board plan to initiate clean-up of our internal ditches beginning with next spring's spring clean-up.
- c. Sand to the front beach area, which has already been properly stoned. Free sand is available from the Bowling Green water treatment plant, free for the picking up.

- d. Installation of a pump in pre-existing well casement at the front pond area is needed, in order to provide for replenishment of the ponds during droughts. If any property owner plans to discontinue their well following city water installation, perhaps they could donate a pump to this worthy cause. Also, we need a new uptake filter for our sprinkler system, which has been mentioned to Ken Schoeni.
- e. Greg Clair will be training additional people in use of our mosquito fogging equipment; we will have a mosquito control program here in the Woods which is certainly superior to that in Bowling Green, which has none.
- f. In our back woods beyond the meadow, some of our signs have worn, and some have been destroyed. These need to be replaced, and it is suggested that these be placed high enough, out of reach of trespassers.
- g. It is suggested that a trail system be created which will allow us access to our back woods for removal of dead wood, and for policing of our property against trespassers when appropriate. The same trails could be used for snowmobiling, hiking, and cross country skiing.
- h. Other uses for the meadow area could be explored ie., golf, a community pavilion, hiking trails, wildlife feeding plots, and a wild flower area.
- There have been concerns regarding possible undermining of the pond banks by muskrats. Attempts to engage a trapper need to be continued.
- j. We should strongly consider hiring students or similar temporary help to assist us in cleaning out our dead trees, particularly on the north end. The amount of labor involved exceeds our capacity, and these areas do need dead wood clean-up to maintain the health of the woods and keep it attractive.

VI. Questions, comments.

VII. Other Business.

- a. Those homeowners who are upgrading their heating systems to high efficiency propane furnaces should remember our requirement that propane tanks be buried here in the Woods.
- b. With our upcoming water project, there will certainly be some necessary damage to our roadway, which will require repair.
- c. There is a strong possibility that major road repairs will be needed in the next several years, given the present rate of wear.
- VIII. Election of new Board members. Outgoing members include Bob Neville, Greg Clair, and Tom Snyder. The floor is open for nominations.

Meeting Minutes

January 14, 1993

The meeting was called to order by Bob Neville, and thanks extended to our hosts, who were Jim and Vicky Graf. The present board members were introduced.

A treasurer's report was delivered by Ted Greene, the details of which may be found by referring to that document.

A summary of events and accomplishments for 1992 was delivered. It was noted that we had had no flooding this year, and that spring and fall clean up had been accomplished, and were getting easier with each passing year. It was also noted that there is considerable dead wood accumulation due to dutch elm disease, which will require some additional attention. The street light project has been finished. Construction plans were approved for the McCleary and Nalls residence, and the Roy Clark addition. Construction is well under way at the Puckett residence on lot #7. Purchase of a commercial quality leaf blower was noted, and the completion of pond treatment and its being hampered by rain was discussed.

Thanks were extended to Ed and Jerry Cleland for restaining the Arlington Woods sign, which truly looks excellent. A tractor complete with brush hog has been acquired from Charlie Ruth. Our thanks to Marsha for an excellent job decorating the Arlington Woods sign for Christmas, which was done very tastefully. The flowerbeds in the front were in the best shape ever, thanks to Jan Neville, Jerry Cleland, and many others who assisted with weeding and other chores on an ad hoc basis.

Brad Hanna has been engaged as our light maintenance man, and his responsibilities will include purchase of globes, fixtures, and performing repairs when necessary. Mosquito control was discussed, and it was agreed that late in the season, after we switched to Resmethrin, mosquito control was generally very effective.

The city water project was discussed; water will probably be in The Woods by December 1993, if the present time table is accurate. The exact route of the water line into The Woods has yet to be decided, and will be tricky to lay out due to the relatively inconsistant placement of our sewer lines. Good relations with the central fire district has been established and maintained, and our thanks is extended these people for their assistance with burning our brush accumulation from the cleanups.

Several evergreens have been transplanted to visible locations along the pond edges by Ed Cleland and Jim Graf. Donations have been made by Woods Property Owners Association in the names of George Henry and Jim Pelton, both recently deceased. Our deepest sympathies were extended to the Henry and Pelton families.

Following this discussion of the year's events, new and ongoing projects for the board were discussed. Continued work with the County on our problems with the middle branch of the Portage will be necessary. Clean up of the section between US 25 and the Amtrack trestle has been promised, and has yet to materialize. Our carryover board members are well aware of this situation.

The need for increased clean up of the Woods' internal ditch system was discussed; this is recognized as an ongoing concern. It was suggested that the new board plan to initiate cleanup of these ditches beginning with next spring's general cleanup. Sand to the front beach area, which has already been properly stoned, will be obtained. The possibility of free sand from the Bowling Green Water Treatment Plant was discussed, and we will be looking into a truck to transport this.

The possible installation of a pump in the well casing at the front pond was discussed, to be used to replentish the ponds during low spells. It was suggested that any property owner who planned to discontinue their well after city water might donate the pump to Arlington Woods for use with this project. Also, It has been conveyed to Ken Schoeni that we need a new uptake filter for our sprinkler system.

Next year's mosquito control program was discussed, and Greg Clair will be training additional people on the mosquito fogging equipment. It was agreed that our mosquito control has generally been good, and even better in the later portion of the summer with the use of Permethrin.

The attrition of our no trespassing/no hunting signs along the border of the back woods was discussed, along with the details of replacing these signs, preferably high enough to be out of the reach of trespassers. The need for a trail system in the back woods was discussed. This trail could be used for snowmobiling, hiking, cross country skiing, and equally important, to allow us access to our property. Other uses for the meadow area of the back 75 were discussed, including possibilities for golfing, a community pavilion, hiking trails, wildlife feeding plots and possibly a wildflower area. There was also some discussion of the need for muskrat control in the front ponds.

Bob Neville suggested that we should strongly consider hiring students or similar temporary help to assist us in cleaning up dead trees, particularly on the North end, where dutch elm has been a real problem. The amount of labor involves exceeds our capacity on a volunteer basis, and these areas do need attention.

There was additional discussion regarding the Woods rule that propane tanks should be buried, with some concern expressed by Tom Snyder regarding the lack of explicit requirements in the regard in the rules and regulations of the Woods. It should be noted, however, that no tanks of any kind are allowed in the Woods without Board permission under the present bylaws.

Problems with cable service were discussed, and it was decided that our system could probably use "winter tuning". This will be brought to the attention of the AmeriCable folks.

The floor was then opened for nominations to fill the Board posts presently . occupied by Robert Neville, Greg Clair, and Tom Snyder. Nominations and seconds were placed for Vicky Graf, Brad Hanna, Eric Sommers, Greg Clair, and Tom Snyder. The election was held, and Vicky Graf, Eric Sommers, and Brad Hanna were elected for two year terms to the Board.

There being no further business, the meeting was adjourned, to be followed by the first official meeting of the new Board.

Arlingon Woods Minutes February 14, 1993

Meeting was called to order by President Ed Cleland. Present were the president, Brad Hanna, Eric Sommers, John Kretzshmar, Vicky Graf and Ted Greene.

The secretary's report was read. Motion by Ted and Second by John to approve. Motion carried.

Treasurer's report was read by Ted Greene. Checking account has a \$5,796.89 balance and the Super Passbook has \$12,101.77. Report unanimously approved by board. Ted made comment that the taxes will be prepared and filed next month.

OLD BUSINESS:

Tentative water extension plans: Plans call for Rt 25 to Rudolph Rd., to Bays Rd., to Rt. 281 and brought into the woods from Bob Neville's property off 281 then loop back to Rt. 25. Plans are expected to be completed by end of 1993.

The clean-up of the ditch thru the woods property is an ongoing effort and discussion was made regarding a more thorough clean-up during spring cleaning.

A new water intake value for the sprinkling system off the pond in front is to be taken care of by maintenance group that deals with this before spring.

Decision made to purchase 25 NO TRESPASSING/NO HUNTING signs to be posted at back of property. Vicky Graf to handle purchase of same.

Mosquito control: Brad, Ed, Roy Clark, and Jim Graf have volunteered to learn the procedure for spraying from Greg Clair. Brad stated the motor needed to be repaired. Ed to look into this prior to spring.

Discussion was held on pavillion and hiking trails in woods. Board decided to table until water cost and project is completed.

A tree form (attached) is a proposed project for planting in the back of the woods; also residents are encouraged to take advantage of this for their own landscaping.

Muskrat control was discussed; Greg Clair and Roy Clark both knew of trappers who may be interested. Ed to check into.

Discussion was held regarding pushing trash from woods clean-up into a large pile for burning. Board checking into people with equipment to handle this.

John mentioned that during a recent problem with his existing propane take, he needed to seek a replacement. The tank will be buried as soon as weather permits according to woods regulations.

Cable TV transformer boosters have been installed this past week; also 2 new channels are to be added.

Lights in entryway are to have all globes changed to have a uniiform

appearance. Brad to take care of ordering and replacing. The existing globes will be used for replacements throughout the woods.

NEW BUSINESS:

Paul Brim asked the association for a donation to help with the Slippery Elm Trail financing (trail from B.G. to North Baltimore via old train tracks). Need \$90,000 by 4/93 to qualify for 1.8 million ODOT grant. John moved and Brad second motion to donate \$500 to the effort. Form enclosed for individual donations.

John moved and Eric second motion to approve purchase of mulcher/ chipper/shredder by Bolens from Amends upon successful completion of demonstration of same. Cost will be \$799 and includes a 3 year warranty. All approved.

The date for Spring Clean-up was set for Saturday, April 3.

Next board meeting set for Sunday, March 28, 1993 at 7:30 at Ed's home. John moved and Eric second to adjourn.
