At the time of this writing, there are:

39% of the Department's non-life members currently past due. This is after removing the over 1-year delinquent members still carried on rosters. This means that 39% of the Department's non-life members cannot vote on detachment business and cannot hold an office. In one detachment, 81% of non-life members cannot vote or hold office.

33% of the Department's Associate members are currently past due. The Department could lose over 20% of our total membership by 31 August. Have the past due members been contacted? National HQ does not send renewal notices. The only contact with members is your Detachment. Contact past due

Ask yourself – Why members not renewing? Why are there so many "One and Done"? 47% of the past due members have not renewed after the first year. What can we do different to make members want to become active members for life?

members and ask that they pay their dues.

There will be a Department Staff meeting in Salina on 27 January at VFW Post 1432 at 12 noon. We will be discussing this and other Department issues.

On March 1, 1945, Cook, a rifleman, was wounded when a bullet entered through his helmet and into the side of his head. He survived and was discharged in September 1945, and was the recipient of a Purple Heart.

In 2016, Lawton Nuss of Topeka, Kansas, was named an honorary member. The Salina native attended KU on a Naval Reserve ROTC scholarship, obtaining a bachelor's degree in English and history and a JD from KU Law School and was commissioned a second lieutenant in the Marines. He served as a combat engineer in the Pacific until 1979. After working as an attorney in Salina for 20 years, Nuss was appointed to the Kansas Supreme Court by Gov. Bill Graves in 2002, and was appointed chief justice in 2010 by Gov. Brownback. We will let Scuttlebutt readers know later this year who was our 2018 honorary member selection.

DEPARTMENT MARINE OF THE YEAR

2018 Marine of the Year Nomination and Award Instructions

This award shall be presented to a REGULAR MEMBER of the Department of Kansas, Marine Corps League who has

- Rendered service(s) and/or performed a deed(s) above and beyond the duties and obligations required of a member of the Marine Corps League, or a meritorious deed(s) so identified as being within the scope of these rules shall be of such substance that the weight will or shall have brought acclaim, and prestige to the member's Detachment and
- Must be substantially involved at the Department or higher level;

and

• Has enhanced and/or furthered the concepts of the duties of being a citizen of the United States of America;

or

• Completed a deed(s) of courage or valor without regard for his/her own safety.

Letters of nomination must originate only at the DETACHMENT LEVEL. No individual nor any subsidiary unit of the Marine Corps League shall submit a letter of nomination. All letters of nomination shall include a letter signed by the Detachment Commandant and Adjutant, stating that the nominee for the Department of Kansas Marine of the Year was approved at a regular meeting of the Detachment by a majority vote. (In the event a nominee is the Commandant; the letter shall be signed by the Sr. Vice Commandant and the Adjutant. In the event a nominee is the Detachment Adjutant the letter shall be signed by the Detachment Commandant and the Sr. Vice Commandant.

Each nomination submitted shall be placed in a sealed envelope and addressed to: "Chairman, Dept. of Kansas MOY Committee". THIS ENVELOPE SHALL THEN BE PLACED IN ANOTHER ENVELOPE and mailed or delivered in person to the Department Commandant no later than 1 April of the year for which the nomination

is made. It shall be the duty of the Department Commandant to deliver the unopened envelopes to the Chairman of the Department Marine of the Year Committee in sufficient time for an awardee to be selected and proper recognition devices to be purchased and engraved prior to the Department Convention. The Chairman of the Marine of the Year Committee shall be elected by the MOY Committee members which shall consist of all previous recipients of the Department Marine of the Year Award. The Marine of the Year Committee shall be the sole judge of all recipients. The Committee shall consist of the previous Marines of the Year and the Department Commandant, who will be a non-voting member of the MOY committee.

Marine Corps History

16 January 1991: Operation Desert Shield became Operation Desert Storm as forces of the allied coalition launched an all-out air campaign against targets in Iraq and occupied Kuwait in an effort to liberate Kuwait and enforce the resolutions of the United Nations Security Council. Overall, in the theater of operations, the coalition forces included more than 415,000 U.S. troops.

18 January 1951: Marines of the 1st Marine Division began mopping-up operations against guerrillas in the Pohang area, South Korea, following the Division's return from its epic battle with Communist Chinese troops at the Chosin Reservoir.

20 January 1968: The second battle for Khe Sanh began when Marines from the 3d Battalion, 26th Marines attacked a North Vietnamese battalion between Hill 881 South and Hill 881 North. More than 100 of the enemy were killed.
