- 3) List all environmental projects, including dates and verification (e.g. thank you letters, if available), that you have been involved with, including at least one project of the St. Clair Shores Waterfront Environmental Committee.
- 4) Answer at least 4 out of 6 questions about Lake St. Clair on a separate sheet of paper (see questions below).

- 3) One letter of recommendation on letterhead from one of your current or past teachers or a recognized civic leader;
- 4) As a group, answer at least 4 out of 6 questions about Lake St. Clair on a separate sheet of paper (see questions below).
