

Hiddenbrook Hosts Octoberfest on Sat Oct 21

Once again, Hiddenbrook is throwing an Oktoberfest party to celebrate the end of the pool season. It is Saturday, Oct. 21 from 5 pm to 11 pm in the Hiddenbrook parking lot.

All Hiddenbrook residents, Swim and Tennis members and guests are welcome. This is an adultonly celebration. There will be beer, wine, and live music. Bring your chairs, tables, and canopies,

see your neighbors and fellow pool friends, and listen to your favorites.

Intimidation Not Acceptable at Hiddenbrook Events

During the September Board of Directors meeting, a written death threat was sent to a member of our management company. While some association issues can be contentious and there can be strong disagreements, no one should be subject to intimidation or fear of harm.

Virginia code 18.2-60 classifies such behavior as a felony with a maximum sentence of 5 years in prison. Know that with modern technology you will likely be identified and prosecuted.

The Board of Directors recently signed a code of conduct, which sets out standards for acceptable behavior. Members are not held to these standards, but it is expected that everyone engages in civilized debate and remember the golden rule – treat others as you wish to be treated.

- The Board is working to amend the current Due Process Resolution to ensure it is in line with the current enforcement process, permitted sanctions as allowed in the governing documents, etc. This document should be finalized at the next meeting on Oct. 19. Upon finalization, members will be notified via email blast and the Mainstream. The final document will be posted on the website.

ARC Standards Update: Removing Ambiguity, Adding Clarity



During the September Board of Directors (BOD) meeting, the Board voted unanimously to host a second Town Hall, which will be 6:30 p.m. Nov. 16 at the Clubhouse.

The goal of the Town Hall is to seek additional feedback on the proposed updates to the Architectural Standards and produce a finalized draft that may be adopted by the Board at a subsequent BOD meeting. The new Standards will be posted on the Hiddenbrook website to allow public review for approximately 30 to 45 days.

The reason the Board has undertaken the task of updating the Standards is due to the realization that there is no guidance for many basic improvements. For example, there is no guidance on siding color, materials, or profiles. This lack of guidance results in confusion for homeowners when submitting applications and also causes difficulties for the Architectural Review Committee when reviewing these applications.

In many cases, because there is no guidance, application approval becomes a preference decision of the current members of the committee. It is the Board's intent to remove ambiguity and provide clarity for Homeowners and Committee members on the current standard architecture within Hiddenbrook.

Additionally, the Board has approved an Architectural Standards Change Process whereby Owners can suggest amendments to the Standards. These proposed changes will be included on the annual Board of Directors election ballot as an addendum. Any changes that get a simple majority will be incorporated into the Standards document.


Board Passes Resolutions cont.

• The Board has adopted an Architectural Standard Amendment Policy in which owners will provide suggestions to the architectural standards for the community. Those suggestions will then be considered by the membership during the annual meeting. This proposal was recommended by the Architectural Review Committee and is currently being reviewed by the Association's legal firm prior to final implementation. We expect to have the final document completed following the next Board meeting on Oct. 19.
