4. BOARD APPOINTMENT OF OPEN BOARD DIRECTOR POSITION

Per TCFA Bylaws 7.3.8 If there is a vacancy on the Board, the Board may fill such vacancy by electing an additional director as soon as practicable after the vacancy occurs, or by appointment from the Trinity County Board of Supervisor responsible for that Directors County Seat.

- Directors will Vote on the Nominees and/or Association Members that have submitted a 'Letter of Interest' for the Open Board Director Position, this is a 1-year term to finish the term of Director Sauer who resigned in January 2024.

 - a. Director Keys abstains from the vote due to being absent.

7. APPROVE JANUARY 2024 FINANCIAL REPORT

a. Director Watkins moves to approve; Director Thompson seconds the motion; Motion carries unanimously.

8. INFORMATIONAL – VACATION/SICK LEAVE BALANCES

9. CEO'S REPORT

- a. Arnie Bridges was hired as Maintenance Supervisor beginning February 1st, 2024. His team won 1st place at Maintenance Mania!
- b. Recap Western Fairs Association Convention: Teresa and I attended the conference in Anaheim in January and came back with some great ideas for new entertainment and vendors:
 - 1. I was elected to represent the Cascade Area as the California Fair Alliance Board Director for the next 2 years, we are working on more Fair Funding
 - 2. Opportunities, the dues are increasing to help fund an activist to lobby for more Fair funding, but also help eliminate Bills that cost Fairs.
 - 3.AB1499 Funds distribution was explained, the 1st check will be sent out in January, and the 2nd check will be paid later in the year.
 - 4. We discussed Jr. Livestock Prop 12, most Fairs are either not auctioning Hogs for re-sale, or are requiring all Hog Exhibitors to provide a letter from the Breeder stating they are in compliance with California Prop 12.
 - 5. Marketing Fairs have become easier with Social Media, we currently have a Facebook Page and Instagram, which we utilize. We also have our website, but due to the security issues with TikTok we currently do not use that platform.
 - 6. We had some great motivational speakers, and the Trade Show gave us an opportunity to see and talk to some new entertainers and visit with a couple we already use. This year we will book a new magician Louie Fox, the Ariel Jean Band that performed at the conference, Brad's World Reptiles that will include exotic animals including an alligator that the attendees can interact with, and we are working on a character balloon entertainer and DJ.
 - 7. There is a Fair Exhibits Course coming up later this month that may benefit us by making our exhibits stand out and get more traffic, and then the Maintenance 'Nuts & Bolts' Training was last week and Arnie our new Maintenance Supervisor attended.
 - 8. When using pictures of people at our events, we need to include signage that States "when you enter Trinity County Fairgrounds your photo may be used on social media and in advertising for TCFA Events".
 - 9. Many Fairs have a Jr. Board, made up of High School Students, I would like to see us come up with a program that would include 5 Jr. Board Directors from each High School and FFA/4H (3 THS, 3 HHS, 1 FFA/4H). We would need a Director to Chair the program and the Jr. Board would write a set of rules that would outline their function, and they would make recommendations to the Board and do fundraising events to support projects on the fairgrounds.

c. CFA update:

- 1. Current Bills that affect Fairs:
 - a) AB415 Emergency Fairgrounds Communication Grant Act, would require the State to establish a grant program to provide fairgrounds with funding for the purpose of building and upgrading communication and internet infrastructure.
 - b) SB59 Menstrual Product Accessibility Act, would require all women's restrooms, all all-gender restrooms, and at least one men's restroom in any building owned by the state to be stocked with menstrual products, accessible and available to employees and the public, free of cost, at all times.
 - c) SB921 Animal Welfare, this bill would make it a crime to otherwise abuse or subject a living animal to needless suffering. The bill would make it a crime for a person to maliciously and intentionally even if the mistreatment does not cause physical injury.
- d. Military Personnel in uniform, currently many Fairs ask that military not be in uniform when attending events on the fairgrounds; currently working on a Bill that would eliminate the 'in uniform' clause.
- e. AB1499, working on increasing the percentage from 3/4% to 1% or higher, still looking for someone to sponsor the bill.
- f. Our Safety Inspection with the State is scheduled for the end of March, Arnie is working with Maintenance to get the punch list from last year done, and some preventative maintenance completed before the inspection. We are also setting up a Forklift Certification in March, which is free and if there are any members or directors that would like to attend, they are welcome.
- g. We have started working on the Exhibitor's Handbook, Advertising Letters have been mailed out and we are already receiving them back. March Board Meeting will be the lottery drawing for the Handbook Advertisement Covers.
- h. We've started booking judges and are working on increasing Membership with more benefits. We are including a Business Banner at our Events, that lists all the Businesses that have memberships.
- i. Grant update: I met with Miller Consulting, the Grant Writing Company we contracted with, and they are looking for USDA Grants, FEMA Terrorism Grants, and CalOES Grants that we qualify for, those will be submitted in the spring. I submitted the grant to Hayfork Chamber for the TOT Grant.
- j. Fundraising events coming up in March are Crab Feed on March 2nd; Bingo March 9th, Texas Hold'em Tournament March 23rd.
- k. I reached out to CalFire to request 2 weeks in June to help with Fair and Jr. Livestock set-up, waiting to hear back if they will have the crew to help us.
- I. Grizz Biggs made 5 prints of his Best of Division Painting of the 2022 Fair; we obtained one of the prints that we have a Silent Auction going until the Dessert & Craft Auction Thursday of Fair. (will be displayed at the Board Meeting)
- m. 2024 is an Audit Year, we have a Financial Review done every year that an audit is not required. Financial Reviews cost us just under \$10,000/year. When Sue requested a quote for our Audit, they gave us a price of \$25,000; she is working on getting that cost down to \$15,000. The last quote she received before Board Packets went out was \$19,500, we have requested a discount based on a 5-year contract, 4 Financial Reviews and 1 Audit, so hopefully we can come up with an agreement and come closer to \$15,000. I reached out to CDFA to request to use our Financial Reviews in place of the required Audit, due to the cost; but because it is written in the CDFA Codes that require an Audit every 3 years, we are required to have an Audit to receive our Annual State Allocation of \$53,000 and our AB1499 Funds.
- n. The 1st Building is not in compliance with Health Codes.
 - 1. We are trying to figure out how to move the building where we need to use it. Making it portable.
- o. We are going to be doing an MOU with Lions Club and Rotary.

 - 4. We are looking at a few different quotes for fans.
 - 5. The septic does work.
 - a) Director Rourke: Are we going to ask again about connecting to the sewer?
 - 1) CEO Bayley: We can connect we just need a holding tank for heavier waste.
 - 6. We have secured a Judge for Poultry and Small Animal; we are still looking for a Large Animal Judge.
 - 7. As of now the animals are as follows:
 - a) Steer 14
 - b) Goats 20
 - c) Lambs 12
 - d) Hogs 80
 - e) Turkeys 23
 - f) Rabbit Pens 6
 - g) Poultry 0
 - 8. We will open registration in March.
 - 9. Dave Cox will give a more in-depth report at the next meeting. Slaughter fees may be down.
 - 10.I will get a list of major repairs that need to be done and get together with Arnie to discuss.
 - 11.March 12th will be the next meeting at 6:00 pm in the THS Ag Room.
