

You are cordially invited to participate in the 28<sup>th</sup> Annual Association of Oklahoma Narcotic Enforcers Inc. We are expecting a large turnout, not only from Oklahoma but from other states as well. Attendees will include not only full time narcotic officers but patrol officers, supervisors, investigators, tactical officers, district attorneys, sheriffs, federal agents and regional commanders.

This will make for easier access to the attendees during registration and between classes. The vendor tables will be prearranged in the room and will be available on a first come basis. The vendor room will be secured each evening so there will be no need to take the tables down each night. A-One will also provide lunches for vendors on Wednesday and Thursday as well providing a ticket to the Thursday night banquet should a vendor wish to attend. Many of the attendees are police executives, task force commanders and administrators who decide on how their department's budget monies are allocated. The conference is an excellent opportunity to exhibit and sell your product.
