

9/10/2018

Sgt. Peska responded to a walk-in complaint at the Sheriff's Office. Upon arriving and speaking the victim/witness a complaint was filed and will be looked into.

Deputy Galloway responded to an electrical line down on State Route 536. Upon arriving in the area, the electric line was removed.
