Running Order and Class Information

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at <u>LKSAGE@aol.com</u> or by phone (503) 840-4303 (cell).

SITE INFO: This trial will be held in two rings indoors on packed dirt. There will be crating on the elevated spectator area around the competition. Crating space is somewhat limited, so we ask that you please conserve on space so that everyone who needs crating will be able to find a spot. Please bring chairs, crates, water and clean up tools for your dogs. You may set up your crating space Sunday afternoon following the conclusion of the Columbia River Agility Club Trials (if you are not entered in that trial).

DIRECTIONS TO THE TRIAL SITE:

From the North, on I-5: Take EXIT 234A toward Fair/Expo/Knox Butte. Turn slight right onto Airport Road SE. Turn right onto Pacific Blvd. SE/OR-99E. Stay straight to go onto Knox Butte Road E. End at 3700 Knox Butte Road E on the right.

From the South, on I-5: Take EXIT 234 toward Fair/Expo/Knox Butte. Turn right onto Knox Butte Road E. End at 3700 Knox Butte Road E on the right.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

VOLUNTEERS: We will also use the white board for sign-ups. If you can, please volunteer for the class(es) that you can help with.

CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

MOVE-UPS: The deadline for move-ups is Monday, March 25, 2019 at 6 pm and must be submitted in writing (email ok).

FOOD: Burton's Catering will be the food vendor on site and will be open from 8:30 am to the end of the trial each day. In addition, there are fast food restaurants within a couple of miles of the fairgrounds.
