Mayor Tobolski asks if there are any public speakers for this evening.

Shirley Gorski stated that she has a follow-up question regarding clarification of Ordinance 19-24 for one of the Trustees to explain the purpose and details. Trustee Carr states that Ordinance 19-24 is a promissory note from the Alta Grill for the start-up costs and construction of the building. The cost of the promissory note is \$285,000.00. Trustee Bubash states that is a one time cost and will not happen again.

Shirley Gorski asks about Resolution 20-R-2. Attorney Perlman explains that this is regarding a FOIA response for which a lawsuit was filed by Chicago Public Media and the Chicago Sun Times. The Village decided it was more cost effective to settle in the amount of \$2,500.00 rather than litigate. Attorney Perlman explained that a response to a FOIA was redacted, therefore they filed a lawsuit. A lawsuit was also filed against the State of Illinois which responded in the same manner.
