Supervisor May called the board meeting to order at 7:30 p.m. at the town hall located at 3529 Rt. 20A, Warsaw, New York. The Pledge of Allegiance was completed and Supervisor May thanked all for attending the meeting.

Public Comments: There were no public comments or questions.

Supervisor May requested a motion to approve the meeting minutes from May 9, 2019. On a motion from Mr. Flint, seconded by Mr. Herman to approve the previous meeting minutes. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried

Zoning Officer Report: Zoning report reviewed. Mr. Elhage was given a building permit to build a residence within the barn structure that he already has built. It will comply with the 1250 square feet requirement. There will be a ZBA meeting to discuss the area variance for Mr. Kaminski, in reference to the location to the new barn.

Supervisor May requested a motion to hold a public hearing on June 13, 2019 at 8pm for discussion on the land separation & subdivision law. Highway Superintendent Report:

1. Week 4/15/2019 Broomed roads, put several loads of 1" crusher run on Wilder, Gasman, Griffen, and Gath (Will be doing our spring grading in the next couple of weeks.).
2. Week 4/22/2019 Changed one driveway culvert and installed one new one on buffalo road, and ditched in the immediate area. Replaced driveway culvert for Darrick Ulm and ditched.

- 3. Week 4/29/2019 Installed new driveway for Philp Ulm on Syler road did Quite a bit of ditching in the area while we were in the area. Replaced driveway for Nancy Ciancio. All four men did Excavator training on 4/30/2019.
- 4. Week 5/6/2019 Ditched on Dunham Road. Cleaning up plow equipment, patching Roads. Installed new Driveway on Gulf Road.

We are getting ready to put some gravel on dirt, and getting ready to crack seal. (need some dry weather) Will be helping Sheldon pave 5/20-5/21. Still waiting to meet with soil and water on Centerline hill, told it will be next week. Met with soil and water and river keepers last week about Krotz road. They have a new plan and are pushing to install new pipe this year. My understanding is it will be a 12' crush pipe, which will be installed by a contractor. Have not talked to the county highway yet, river keeper explained that the county would take over maintenance of the new pipe. From the towns stand point there are still some concerns, (road width, Surface when job is complete, proof that we are not responsible after completion). Please let me Know with any concerns the board may have. We just got the Chips letter we will receive \$106,969.25 for chips and \$24,416.80 for pave NY. There will be no extreme winter recovery funding this year.

Town Clerk Report: Our Town website visits for May was 2066. The Towns total revenue for the month of April 2019 was \$452.00, \$297.00 for dog licenses, \$50.00 for late fees, \$105.00 for Zoning. We had 25 renewal license and 3 new license. To the general fund, Supervisor May \$228.00, Dogs were \$73.00, \$50.00 in late dog license fees, \$105.00 for Zoning. We disbursed \$180.00 to Wyoming County, \$44.00 to Ag and Markets for dogs. No marriage licenses this month.

Mary Kehl has given the Town a check for \$4,600, to be divided between the Youth and the Seniors. It was also noted that 4-H Camp did not respond to the letter requesting information regarding tables and chairs for the camp dining hall, in turn the money was donated to Gateway House in Attica.

Supervisor May noted that Mr. Ahl has done a great job on the front, under our new sign. There was also discussion on hiring a person to landscape the front of the Town building.

Supervisor May requested a motion to approve the 2019 Highway Fund Bills: Abstract #5 Vouchers #68 through #86, totaling \$27,958.14. A motion was made by Mr. Herman, seconded by Mr. Flint to approve the payment of the Highway Fund bills. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried

Supervisor May requested a motion to approve the 2019 General Funds bills: Abstract #5 Vouchers #71 to #85, totaling \$11,038.46. A motion was made by Mr. Boxler, seconded by Mr. Ahl to approve the payment of the General Fund bills. Ayes [5] May Boxler Flint Herman Ahl. Noes [0] Carried
