Ordinance O-2017-03

**AN ORDINANCE CHANGING THE POSITION OF MAYOR'S COURT CLERK
AND ASSISTANT TO THE POLICE CHIEF TO A PART TIME POSITION
AS MAYOR'S COURT CLERK AND DECLARING AN EMERGENCY**

WHEREAS, Amelia Village seeks to change the position of Mayor's Court Clerk and Assistant to the Police Chief to make it a part time position known as the Mayor's Court Clerk.

NOW, THEREFORE, be it ordained by the Council of Amelia Village, Clermont County, Ohio, that;

SECTION I. the position of Mayor's Court Clerk and Assistant to the Police Chief shall be changed making it a part time position to be known as the Mayor's Court Clerk. The pay for this position shall remain the same at \$18.10 per hour. The duties for this part time position of Mayor's Court Clerk shall be as outlined in the attached Exhibit A.

SECTION II. Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION III. That this Ordinance is hereby declared to be an emergency measure for the preservation of the public peace, health, safety and general welfare of the Village. The reason for such necessity is to change this position to ensure the orderly and consistent operation of the Police Department of Amelia Village and its Mayor's Court. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members elected to Council, this ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.

MR. CAMPBELL moved to suspend the rules requiring three readings on three separate dates.

MR. MELLENDEZ seconded the motion.
