No lot survey is required for painting or staining or siding, window or roof replacement.

Color samples are required for paint, stain, solar screens, roof, brick or colored siding.

If you do not submit the survey or drawing, samples and any other required or subsequently requested information, this will result in a delay and/or rejection of your application.

**IMPORTANT:** I understand that: (i) the Architectural Control Committee will act on this request as quickly as possible and contact me in writing regarding their decision, however, the Committee is allowed thirty (30) days from receipt of this application to respond, in writing; (ii) in the event the work to be done is not started within six (6) months from the date of approval by the Committee, a new application will need to be submitted and approved before work begins; (iii) it is my responsibility to ensure compliance with all applicable governmental ordinances, codes, permits, etc. affecting such modification(s) and (iv) I can not begin any changes or additions until the Committee notifies me, in writing, of their decision.

**SUPPLEMENTAL INSTRUCTIONS FOR APPLICATION FOR APPROVAL TO MODIFY  
HOME OR PROPERTY**

If you are applying for:

A structure (e.g. PATIO COVER, ARBOR, GAZEBO, STORAGE SHED, ROOM ADDITION, ETC.) you need to submit an elevation drawing showing how the structure will look. Please indicate size, height, color, materials and roofing and show placement on the lot survey.

A play structure (PLAY HOUSE, SWING SET, TRAMPOLINE, BASKETBALL GOAL, ETC.) you need to submit a photo, brochure or drawing. Please indicate size, height, color, materials, etc. and show location on the lot survey.

A POOL/SPA you need to submit a detailed drawing of the pool/spa and indicate on the lot survey the location of the pool/spa and its related equipment. You should also show the construction access point at the rear of the property.

Exterior PAINTING OR SIDING submit color samples, including trim.

A new ROOF please submit manufacturer's name and color name (include a brochure or small sample) of the roofing materials to be used.

New FRONT DOORS OR STORM DOORS please provide photos or brochure.

SOLAR SCREEN/WINDOW TINTING please provide material samples.

WROUGHT IRON GATES please submit drawing and color and indicate placement on the lot survey.

DECKING/PATIO please indicate location on the lot survey, the materials to be used and the height of the decking/patio.

CONCRETE WORK/PAVERS (walkways, sidewalks, driveway extension, etc.) please indicate location on the lot survey.

LANDSCAPING OR TREE REMOVAL/REPLACEMENT please submit all details (tree dimension and type) showing placement on the lot survey.

FENCING please submit details about the height, construction, all materials to be used and location on the lot survey.

YARD DECORATIONS (birdbath, benches, statues, signs, lighting, etc.) please submit a photo or brochure and indicate the location on the lot survey.

Note: The above list is NOT meant to be all-inclusive but is only illustrative of sample improvements and what is required.
