#### **Public Comments**

Kathleen Graffam stated that several school districts, including her local district, School District 106, were under-allocated a considerable amount of interest according to the Quarterly Average Fund Balance & Interest Allocation Examination Report that was presented at the last board meeting. Ms. Graffam asked if asked if the there was any plan to compensate the school districts for these under allocations. President Thiessen responded stating that this has been the ultimate goal and why the LTTO has been in litigation with District 204. The Board is trying to determine, in the element of fairness, to get all district back to what their rightful share of the interest allocations should have been and not a decision that the judge will make, so these are decisions that the Board will most likely have to make over the coming months.

#### Recognition of Outgoing Trustee Michael J. Dickman

Trustee Theissen thanked Trustee Dickman for being an honorable, noble public servant and for being a professional and personal friend to him over the years. Treasurer Getty noted that the last six years have been transformational at the LTTO and that during Trustee Dickman's tenue the LTTO has allocated \$22 million dollars in interest to member districts. #### **Review School Districts Official Records**

Board of School Trustees discussion and review of the LTTO member district financial records for April 2021. At the April 2021 meeting Treasurer Getty express concern that property tax distributions were down approximately 8% at that time, however, he noted that very shortly after that meeting the Cook County Treasurer made additional distributions that have resulted in very similar year-over-year total property tax deposits to the LTTO. These additional deposits and high levels of liquidity has allowed the LTTO to capture additional yield on our short-term portfolio to help offset the reduction in overall interest rates. Treasurer Getty also noted one audit adjustment that was made in April.

#### Lyons Township Summer Employment Work Program

The Lyons Township Summer Youth Employment Program is administered by the Township and offers summer help to government entities within the township and provides summer jobs student residents. The LTTO participated in the program four years ago and found it to be a very positive experience. The individual who participated in the program at that time was ultimately hired as a part-time LTTO employee after the summer work program expired and continued working for the LTTO until he graduated college and found full time employment. Treasurer Getty would like to again request authorization to participate in the program to help with record digitization and retention program over the upcoming summer.

#### **OLD BUSINESS:**

#### Pro-Rata Receivables - FY2020

FY2020 Pro-rata bills were sent to all member districts and Treasurer Getty noted that the LTTO has received payment in full from Districts 103, 104, 109 and LADSE.

#### Lyons Township Trustees of Schools Audio Recording Policy

Treasurer Getty presented a summary of which member districts publicly post audio and/or video recordings, where they are posted and which districts have a written policy in place for the recordings. Treasurer Getty noted that none of the existing recordings appears to be downloadable. Additionally, only District 107 has a written policy and it has been in place since 2015. President Theissen asked Treasurer Getty to investigate what equipment and/or services would be needed to post audio and/or video recordings of the LTTO Board meetings.

# Matters related to the possible withdrawal of Lyons Township High School District 204 from the Township Trustees of Schools, Township 38 North, Range 12 East, County of Cook, State of Illinois at the conclusion of FY2021

Treasurer Getty informed the Trustees that there was a legislative bill in committee that would have allowed District 204 to withdraw from the LTTO immediately, but that bill has not been moved forward.
