What is the credentialing process?

The credentialing process is the granting of privileges and/or membership that authorizes the practitioner to perform certain clinical functions for which they are deemed qualified and competent.

The standard credentialing process begins with the review of the submitted application for completeness. This process also includes primary source verifications.

Examples:

- ✚ State License, Federal DEA, Pharmacy
- ✚ Liability Insurance
- ✚ Medical Education
- ✚ Board Certification(s)
- ✚ Work History
- ✚ Hospital Privileges
- ✚ Peer References
- ✚ National Practitioner Data Bank (NPDB)
- ✚ Medicare Opt-out
- ✚ Office of Inspector General
- ✚ Criminal background checks

MSPs are the gatekeepers of patient safety, ensuring quality care through the credentialing and privileging of healthcare providers in an ever-changing industry.

MSPs must be ready to innovate and adapt to new responsibilities, motivated to expand our knowledge, and most importantly focused on the future of patient safety.
