#### A. Consider and Discuss Property Owned by City of Cisco on Jackson St. (Executive Session)

### B. Consider and Discuss Selling Lake Lots 39 & 40—Van Newberry

Mr. Archer explained that the Council had previously discussed selling the lake lots to the current lessees, but further stated that the city is required to go out for bid for any sale of real property and so there would be no guarantee that the current lessee would be the high bidder. He recommends staying with the current lease set to expire in 2070. Mr. William Wright, Jr., City Attorney, further said that there could also be potential issues with selling the property because they are not large enough to legally have septic tanks by individual owners, adding that city owned property is exempt from that regulation.

AN ORDINANCE OF THE CITY OF CISCO, TEXAS AMENDING CERTAIN SUBSECTIONS OF CHAPTER 14 "OFFENSES AND MISCELLANEOUS PROVISIONS" OF THE CITY'S CODE OF ORDINANCES; SPECIFICALLY ARTICLE VI "NOISE", SECTION 14.93 "VEHICULAR NOISES", PROHIBITING THE USE OF COMPRESSION RELEASE ENGINE BRAKES IN THE CITY LIMITS OF THE CITY OF CISCO, TEXAS WITHOUT CERTAIN ADEQUATE NOISE MUFFLING SYSTEMS; AND PROVIDING FOR AN EFFECTIVE DATE.
