LANDSCAPE NOTES

Happy summer to you, friends and neighbors of Chantarelle. Here is the hot-off-the-press update from your Landscape Committee. Summer Lawns: Summer has arrived and wow, we are having a hot one so far this year! And the heat is definitely having an impact on all of our lawns. The Waldron team is testing the sprinkler system quite regularly, and fortunately so far, everything is in good working order. Minor tweaks are being made here and there, but for the most part, our new lawn sprinkler system is working just as well as we had anticipated. However, the lawns are currently ranging from fairly green in some locations to quite dry and brittle in others, and many steps inbetween. We know this is a concern to many of you, and understandably so. We certainly want to preserve the beauty of our landscape by keeping the lawns as green as possible, given the conditions of summer heat and the need to be mindful of water conservation.

Continuing Water Conservation:

Even though we had a nice wet winter (yay!), California is still in a long-term drought situation. Yes, some municipalities, including Sonoma, have released the requirement for significant watersaving measures. If we were to water every night, our lawns would be as green as golf courses. But

as stewards of our community landscape, we do not consider that to be a wise and conscientious decision. Here in Chantarelle, we intend to keep our lawn-watering to a maximum of three nights a week, the same as our watering strategy last summer. Sprinklers come on twice a night in each area, for 25 minutes per watering session. The length of watering time has been doubled from last year because the new sprinkler heads emit half the amount of water, enabling the water to be absorbed by the earth rather than run off. Because our irrigation water comes from our well. we respect the need for replenishment of water levels in our aquifers which we share with all our neighbors here in the Valley of the Moon. Local aquifers have been drastically drained during the heavy drought years. Also, we are being mindful of the fact that we are not out of the woods yet with regard to the drought. So we are seeking the ideal balance between conscious conservation and watering enough to preserve just enough green in the height of summer to be as lovely as possible, given our conditions. Once the rains return in the autumn, the more vibrant green will be restored to our lawns, just like last fall when the rains began. The lawn roots haven't died; the green grasses just wither in the height of this intense heat. If you happen to notice any problems with the irrigation in front of your house, please do not hesitate to contact one of us, as we want to get any and all irrigation issues resolved as quickly as possible. Thank you for your help with this! A Request Regarding Wheels and Sprinklers: As you not doubt have observed, the sprinkler heads for the lawns are located at intervals around the perimeter of each home's lawn. This includes

heads that are lodged between the lawns and the driveways to our garages. Because the sprinkler heads are sensitive and can be damaged easily, here is our request of all our homeowners: Please make ever effort, when coming and going on your driveway, to keep your wheels on the concrete. No doubt we all do try to do this! But what you may not know is that if you go off the driveway even just a little bit and happen to run over a sprinkler head, it can do serious damage. So may this awareness inspire each of us to be just a tad more mindful as we come and go from our homes to steer clear of our sprinkler heads. We thank you so very much for your attention to this detail. That's it for now. May you enjoy a splendid Independence Day celebration and we look forward to seeing you around the neighborhood. CHANTARELLE POOL RULES

- 1. Persons using the pool and pool area assume all liability for such use and agree to hold harmless the Chantarelle Homeowners Association, its members, directors, officers and employees in case of accident, injury, theft or loss of personal property, Or other calamities.
- 2. Pool hours are 6 a.m. to 10 p.m. The pool is heated May 1st through October 31st.
- 3. There is no lifeguard on duty at any time.
- 4. All persons must shower before entering the pool.
- 5. Diving and jumping into the pool and running or pushing in the pool area is prohibited.
- 6. No glass of any kind is allowed in the pool or on the concrete covered area outside the clubhouse.
- 7. To avoid littering, trashcans should be used.
- 8. Pets are not allowed in the pool area.
- 9. Unnecessary noise is not allowed at any time.
- 10. Before leaving the pool area, please remove debris, clean the tables, and close umbrellas.
- 11. Children in the pool area who are less than 18 years of age must be accompanied by an adult.
- 12. A homeowner's guests may

use the pool without the homeowner being present, provided the guests obey all the pool area rules. Residents are responsible for the conduct of their guests and must see that rules are obeyed.

- 13 Children using the pool must be at least three (3) years old, potty trained and may not be in diapers.
 14. Lap swimming hours are from 9:00 a.m. to 11:00 a.m. on weekdays.
- 15. "Children's Hours": persons under age 18 are allowed to use the pool from noon-2 and 4-6 during the week and from 12-6 at weekends.

Chantarelle Homeowners Association – Age Certification

- 1. The age restrictions for occupancy of a lot ("lot") at Chantarelle Homeowners Association are set forth in Article VIII of the Association's Declaration of Covenants, Conditions, and Restrictions.
- 2. Federal Law requires that the Association verify the ages of all residents and requires identification be provided to support the information on this form.
- 3. Any guest that stays more than 60 days in any 12 month period is considered a resident under California law and must be included in this Certification.
- 4. Homeowners who are renting/leasing their homes must also comply with the policy and complete this form including copies of identification for each tenant.

AGE CERTIFICATION

Please initial the applicable statement below \underline{AND} attach a copy of identification (driver's license, California ID card, passport, birth certificate, immigration card, or similar ID) for \underline{all} occupants.
