GRANT MINNICH MADE A MOTION WITH CURTIS HAMRICK SECOND TO ACCEPT THE READING OF THE FEBRUARY TOWNSHIP MEETING.

TRUSTEES REVIEWED AND SIGNED A CONTRACT WITH MERCER CO. EMS FOR THE YEAR 2016 TO PROVIDE SERVICE TO 612 PEOPLE AT THE RATE OF \$2.50 PER CAPITA WITH A TOTAL COST OF \$1,530.00. CONTRACT IS RESOLUTION #02-16.

THE TOWNSHIPS OLD SNOW PLOW HAS BEEN PICKED UP BY THE PURCHASER FROM WEST VIRGINIA. CHECK FOR \$2,177.20 WAS RECEIVED AND DEPOSITED.

A DUMPSTER WILL BE SET AT THE TOWNSHIP HOUSE BY THE COUNTY FOR LITTER PICKUP ALONG COUNTY ROADS ONLY.

THE DOLLAR AMOUNT OF \$34,200.00 FROM OPWC MONIES WILL GO TOWARD CHIP AND SEALING OF TOWNSHIP ROADS. ESTIMATED COST FOR CHIP AND SEAL IS \$13.820.00 PER MILE.


ROADS TO BE CHIP AND SEALED FOR 2016 ARE:

CLOUSE ROAD 1/8 MILE
STATE LINE ROAD 1 ¼ MILE NORTH OF STATE ROAD 707 TO END OF STATE LINE.
BURRVILLE ROAD 1 MILE FROM STATE ROUTE 707 SOUTH TO TOWNSHIP LINE
ERASTUS DURBIN ROAD 1.75 MILE FROM ROCKFORD WEST TO US 33
