Once your parade registration has been processed, we will mail you your entry confirmation and entrant number. Your entrant number will need to be displayed on your boat during the parade for judging purposes.

Channel Islands Harbor 2018 4th of July Electric Boat Parade

Parade Lineup:

- 1) Lead Boat: Central Coast Electric Boat 22' Sun Cruiser with top revolving light
- 2) All parade participants fall in randomly after the above vessel is underway.
Spacing between vessels should be approx. 100 feet. Parade speed will be 4MPH.

Turn Boat Location:

- 1) East Channel by launch Ramp.
- 2) West Channel by PCYC.

Details:

- 1) Stage in front of the old Lobster Trap restaurant; 3:30pm. Parade starts at 4:00pm.
- 2) Upon start of parade, travel up the east side of the East Channel to just past the launch ramps, leaving the turn boat to port. Proceed down the west side of the East Channel, looping past the Lobster Trap/Casa Serina and turn east again up the Main Channel. Leave the turning boat stationed in front of Channel Islands Bridge to port and stay on the west side of the Main Channel all the way to the official finish in front of Channel Islands Yacht Club. Some boats may wish to continue their festive presentation after the finish by continuing on to the Channel View Park, a popular spectator area.
- 3) Communicate on VHF 12 for parade info and details, if you have a VHF radio.
- 4) VHF 16 is for EMERGENCY TRAFFIC.

Emergency - Breakdown:

- 1) Maneuver off the active parade route to a safe location out of harm's way.
- 2) Call Central Coast Electric Boats (805) 985-4563
- 3) Central Coast Electric Boats will respond to your location or give you instructions.

Emergency – Fire or Medical:

- 1) Turn towards the center of the channel (port) away from the parade route.
- 2) Call the Harbor Patrol on VHF 16 or (805) 382-3000 (Emergency)
- 3) The Harbor Patrol will respond.

Navigation Safety:

- 1) Watch for small vessels, including kayaks, navigating around and between the parade route. PLEASE keep in mind many of the stand-up paddle boarders and kayakers do not know the nautical “rules-of-the-road” and you should be prepared to yield to them under ANY circumstance.
- 2) Keep your vessels speed safe, under 4 MPH, and be conscious of your vessels wake. Keep a 100' distance between your vessel & the vessel you're following.

Waiver of Liability, Assumption of Risk, and Indemnity Agreement

Waiver: In consideration of being permitted to participate in any way in the Central Coast Electric Boat and Channel Islands Yacht Club's Electric Boat Parade, July 4, 2018, hereinafter called "Activity", I, for myself, my heirs, personal representatives or assigns, do hereby release, waive, discharge, and covenant not to sue Central Coast Electric Boats or Channel Islands Yacht Club, its officers, employees, and agents from liability from any and all claims resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in Activity. Activity period is 4:00 PM to approximately 5:00PM, July 4, 2018 only.

Assumption of Risks: Participation in Activity carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries or property damage. The specific risks vary, but the risks range from 1) minor and/or major injuries 2) catastrophic injuries 3) intentional and/or unintentional property damage.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in Activity I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

Indemnification and Hold Harmless: I also agree to INDEMNIFY AND HOLD Central Coast Electric Boats and Channel Islands Yacht Club HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in Activity and to reimburse them for any such expenses incurred.

Severability: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgment of Understanding: I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily, and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
