### APPROVAL OF MINUTES

Trustee Foley made a motion to approve the minutes of JULY 24, 2018 meeting of the Collinsville Township Board. Trustee Royer seconded the motion. Roll call found the vote unanimous. Motion carried.

The Town fund bills for \$50,516.18 were read. A motion to approve the bills as read was made by Trustee Foley and seconded by Trustee Royer. Roll call found the vote unanimous to pay the Town fund bills for \$50,516.18. Motion carried.

### **UNFINISHED BUSINESS**

Collinsville V.F.W. president, Mark Lankford spoke, informing the Board how the V.F.W. distributes its funds. They keep their money locally because this is where our Veterans go for their health care. The local hospitals are Jefferson Barracks and John Cochran in St. Louis. They also donate to Veteran Homes. He requested a donation for their yearly car show, which benefits the Veterans. We were unable to call for a vote because it was not on the Agenda. It will be on the next agenda and we can vote at the August 28, 2018 meeting. Next discussion was about moving the Township Meetings to the Senior Center. Supervisor Allan stated it's best to keep the meetings here in the conference room because all paper work is here when we have to refer to something. A discussion was held and ended with Supervisor Allan stating he prefers voting on this when the full Board is present. A motion was

made to table the moving of meetings to the Senior Center by Trustee Foley and seconded by Trustee Royer. Roll Call found the vote to be three ayes and one no. Trustee Cox voted no. Motion carried.
