1. **Sign-In:** Each member and any invited guest must sign-in before entering the pool.
2. **Identification:** The pool manager or any lifeguard on duty has the right to ask for identification from anyone at the facility
3. **Breaks:** At 10 minutes before every hour, the lifeguards will blow a whistle for a mandatory rest period for all children under the age of 16. **The only children allowed** in the pool at this time must be accompanied by a parent and **age 4 or younger.**
4. **Baby Pool:** No child over the age of 6 is allowed in the baby pool at anytime. This applies to pool rentals, as well. All children in the baby pool area are to be attended by a responsible adult at all times. No disposable diapers are to be worn in either, as they release chemicals that will contaminate the water.
5. **Parents:** No child under the age of 10 is allowed to swim without parental or adult supervision. A parent may appoint a Club Member age 14 or older to supervise their child or children in the parents absence. If the supervising Club Member is between the ages of 14-17, we recommend supervising no more than two children under the age of 10, however, the number of children being supervised is left up to the good judgment of the parents. **It is imperative that** parents of children under the age of 10 closely monitor their child or children. Arm floats, ring buoys, noodles, etc. are not a substitute for close parental supervision. Lifeguards are always on duty, but parents are still responsible for their family.
6. **Objects:** Food, drinks and/or smokeless tobacco are not allowed within five (5) feet of the pool. No glass objects of any type will be allowed inside the Club at anytime. Lotions, etc., must be in plastic containers
7. **Showers/Cuts:** All members are requested to shower before entering the pool. Any person with cuts, blisters, and/or open sores should refrain from use of the pool until healed.
8. **Safety:** For the safety and enjoyment of everyone, the following **will not be permitted:** running, spitting, horseplay, pushing others in the pool or on the deck, dunking, wrestling, large floats and water cannons. No ball throwing on the deck.
9. **Zero Tolerance:** Pinebrook has zero tolerance for bullying and failure to comply with pool rules. We have implemented a 3 strikes rule. This rule applies for regular pool hours and swim team practices. If an incident report is completed on a child 3 times, they will not be allowed at the pool the rest of the season. Parents will be notified by either the pool manager, lifeguards, swim team coaches or board members.
10. **Diving Board:** Only one (1) person will be permitted on the Diving Board at a time. Diving is permitted only after the previous diver has surfaced and left the diving area. It is the responsibility of each diver to assure that the area is clear before diving.
11. **Life Guards:** Everyone should stay clear of the lifeguard chairs and refrain from distracting the lifeguards.
12. **Authority:** The manager and lifeguards are in control of the pool area and have the authority to enforce all rules.
13. **Guest Policy:** Members may bring a guest(s) any time the Club is open to the general membership for a fee of \$5.00 per person per visit. This fee may be waived by purchasing a season-long guest pass for \$100.00. A guest pass may be purchased at any time, however, a member cannot apply previous single day guest pass visits towards the purchase of a season Guest Pass. A guest can only use the Club five (5) times in one (1) year. There is a limit of five (5) guests per visit per Guest Pass holder. If you own a Guest Pass and want to bring in a guest over the limit of five (5), you may pay an additional \$5.00.

14. **Chaperone Passes:** These are approved and issued by the Board of Directors. This pass is for an individual caregiver of a member's child(ren). The pass does not include the caregiver's family or friends and can only be used when in the company of a member's child(ren). The fee for the season pass is \$50.00.
15. **NO DIVING:** There are "No Diving" markers on the pool border. Pay attention. No Diving is allowed in shallow water.
16. **Pets:** Due to health regulations, NO pets of any kind are allowed within the fenced area of the Club facility.
17. **Parties:** Parties may be held during regular pool hours for a fee of \$50, plus lifeguard fees. The Pool Rental form and Pool Party Request form must be completed at least one week prior to party date. The \$50 Party fee is payable to Pinebrook and the lifeguard fees are detailed on the Pool Party Request form and payable to pH Pool Management. Each attendee must have a signed Guest Liability Waiver on file.
18. **Pool Rental:** The pool may be rented by families, churches or civic groups, etc. any time the pool is not scheduled to be open for the general membership or for swim team meets. If a non-Club Member is requesting the pool, a Member family must sponsor and co-sign rental form.

Each attendee must have a signed Guest Liability Waiver on file.

**Rental is subject to the following conditions:**

- A. The Pinebrook Swim Club, Inc. Board of Directors must receive pool rental requests, pool rental form and certified check (personal check OK for member) o (2) weeks prior to the requested rental date. If the requested date is not available, the rental fee will be refunded or another open date may be selected. Pool Rental form MUST be mailed. If two (2) parties request same date, postmark will determine rental.
- B. Anyone renting the pool must agree to abide by the safety rules/regulations of Pinebrooks Swim Club, Inc. and is responsible for any damages to the pool, facility and/or property casued by any member of or guest participating in the rental party. The renting Member's dues must be paid in full and all membership forms must be up to date.
- C. The number of lifeguards required is determined by pH Pool Management.
- D. The minimum pool rental fee is \$150.00 for two (2) hours and 75 guests. Guests are defined as all who enter the deck area. Each additional hour and 25 guests will require an additional \$50.00 fee.

E. The total number of attendees must be listed on the completed form. NO EXCEPTIONS.

F. Lifeguard fees are paid separately to pH Pool Management. Pool Party Request form must be received by pH, with payment, at least one week prior.

19. **ABSOLUTELY NO ALCOHOLIC BEVERAGES ARE PERMITTED ON THE PREMISES OF PINEBROOK SWIM CLUB, INC. AT ANY TIME. PINEBROOK SWIM CLUB IS A SMOKE-FREE FACILITY.**
