Requirements and Privileges

General Requirements

1. All members shall be at least 21 years of age.
2. All members shall share in the fellowship of leather common to The Columbia Leather Order, Inc. membership.

Associate Members

1. Anyone meeting the General Requirements may apply for Associate membership as outlined in current Policies and Procedures.
2. Applicants for Associate Membership residing within 70 mile radius of Columbia, SC are required to attend two regular meetings or events before an application for Associate Membership will be considered.
3. Out-of-town applicants for Associate Membership shall be exempt from the above requirement, but must be sponsored by a minimum of one Full member of the Club.
4. Following receipt of the application and one-time fee for Associate Membership and fulfilling the requirements, the application shall be presented for approval during the closed session of the next regular meeting. The applicant must be present or make other arrangements approved by the board to be considered for membership.
5. Associate Members shall pay dues as outlined in current Policies and Procedures.
6. Associate Members shall have no voting power and shall make no commitments on behalf of The Columbia Leather Order, Inc.
7. Any Associate may chair a committee designated for Associates. Associates will be informed of, as is possible, and invited to all meetings and events, except those designated for Full Members Only.
8. Associate Members may wear a small The Columbia Leather Order, Inc. Associate patch.
