#### 2012 Annual Meeting Faculty



**Amber M. Bradley, Pharm.D**. is a Clinical Assistant Professor in the Department of Clinical and Administrative Pharmacy at the University of Georgia College of Pharmacy in Augusta, GA.

Dr. Bradley earned her Doctor of Pharmacy degree at the University of Michigan College of Pharmacy. She then went on to complete her ASHP-accredited PGY1 residency at the Medical College of Georgia (MCG Health) followed by her PGY2 residency in hematology/oncology at the University of North Carolina Hospitals and teaching certificate program at the UNC Eshelman School of Pharmacy in Chapel Hill, NC. She currently practices as a clinical specialist in adult hematopoietic stem cell transplantation at the Georgia Health

Sciences Medical Center where she precepts fourth year pharmacy students, PGY1 residents and PGY2 hematology/oncology pharmacy residents. Dr. Bradley is a member of the Georgia Health Sciences Health System Cancer Center, the American Society of Blood and Marrow Transplantation (ASBMT), Hematology Oncology Pharmacy Association (HOPA) and the American Society of Health-System Pharmacists (ASHP). Her research focuses on the scholarship of teaching and learning, as well as improvement in medication use, outcomes, and supportive care in hematology/oncology and hematopoietic stem cell transplant patients.



Ross Day is a Director in the Pharmacy Department at Novation. For twelve years, Mr. Day has provided strategic oversight for the development of NOVAPLUS® pharmaceutical contracts and the development of NOVAPLUS programs. Since coming to Novation in September of 1999, he has facilitated the expansion of the successful NOVAPLUS pharmaceutical portfolio from sales of around \$280 million per year to annual sales that have exceeded \$1 billion for each of the last three years. In addition to strategic oversight of the NOVAPLUS program, he has managed the relationship and contracting responsibilities for several of Novation's highest profile pharmaceutical manufacturers, including GlaxoSmithKline Pharmaceuticals, Abbott Laboratories, Hospira Worldwide, Pfizer Pharmaceuticals, Sanofi Aventis

Pharmaceuticals and Baxter.

In Mr. Day's current role in the pharmacy department, he provides first line management oversight to a group of Portfolio Executives managing Novation's generic injectable supplier contracts. Those contracts provide over \$1.3 billion in contract sales and \$95 million in revenue to Novation annually.

Prior to his arrival at Novation, Mr. Day was a Director of Pharmacy for twenty-five years in various healthcare organizations, the last ten of which were in the Memorial-Hermann Healthcare System in Houston, Texas, a charter shareholder of VHA.

Mr. Day received his Bachelor of Science Degree in Pharmacy from Southwestern Oklahoma State University in Weatherford, Oklahoma, and maintains current pharmacist registration in the states of Texas and Oklahoma.









Houston College of Pharmacy in Houston, Texas. He also serves as Division Head, Experiential Therapeutics and Clinical Pharmacology. Additionally, he holds an academic appointment as Adjunct Associate Professor at the University of Texas School of Public Health in Houston.

Dr. Garey earned his Bachelor of Science in Pharmacy from Dalhousie University in Halifax, Nova Scotia, Canada. He earned his Doctor of Pharmacy degree from the State University of New York at Buffalo, in Buffalo, New York and a Master of

He also completed an Infectious Disease Residency and Fellowship in Infectious Diseases at the University of Illinois at Chicago, Illinois.

Dr. Garey is an active member of the Society of Infectious Diseases Pharmacists and the American Society of Health-Systems Pharmacists (ASHP). His research interests include antimicrobial stewardship activities to prevent and treat *Clostridium difficile* infection and systemic candidiasis. He has received numerous awards recognizing excellence in research, teaching, and publications. In 2010, Dr. Garey received the ASHP Best Practices Award in Health-System Pharmacy.



**Richard Green** began his career on the bottom rung of the radiopharmacy ladder, as a driver in a radiopharmacy making deliveries to hospitals and clinics - where he was obviously bitten by the nuclear bug.

As a result, he pursued a career in nuclear pharmacy, graduating from the University of Arizona in 1988. He has managed radiopharmacies in Las Vegas, Nevada and Phoenix, Arizona and managed the first

commercial (Positron Emission Tomography) or PET cyclotron radiopharmacy in the country.

Today with 30 years of experience in the industry, Richard is the chief nuclear pharmacist at Cardinal Health Nuclear Pharmacy Services where he currently serves as the Director of Radiopharmacy Practice. From his office in Dublin Ohio he leads Cardinal Health's staff of radiopharmacists and radiopharmacy technicians located in 148 radiopharmacies in North America. He is also one of only 430 Board Certified Nuclear Pharmacists *in the world*.

Charlotte Hayes MMSc, MS, RD, CDE holds a BS degree in clinical dietetics and community nutrition from Iowa State University, Ames Iowa. She completed a dietetic internship and MMSc degree in Clinical Dietetics from Emory University School of Medicine and a MS degree in Adult Fitness and Cardiac Rehabilitation from University of Wisconsin-La Crosse. After working for over 10 years in a busy in-patient and out-patient DSME/T program with a high volume of intensively managed patients with both type 1 & type 2 diabetes, Charlotte spent 5 years in private practice. Since 2004, she has led development of programs and policy at Open Hand/Atlanta, a community-based organization which provides nutrition and health programs throughout the Atlanta community. She has served on editorial boards, has published, and guided professional

programs with the American Diabetes Association, American Academy of Nutrition and Dietetics and the American Association of Diabetes Educators (AADE). She is currently serving on the AADE Board of Directors.



**Patricia Clancy Kienle, RPh, MPA, FASHP** is the Director of Accreditation and Medication Safety for Cardinal Health Pharmacy Solutions.

She received her pharmacy degree from the Philadelphia College of Pharmacy and



Science, and a Masters in Public Administration from Marywood University in Scranton, Pennsylvania. She completed an Executive Fellowship in Patient Safety from Virginia Commonwealth University and is an Adjunct Associate Professor at Wilkes University in Wilkes-Barre, Pennsylvania.



She has served on the Pharmacotherapy Specialty Council of the Board of Pharmaceutical Specialties, as the pharmacist member of the Hospital Professional and Technical Advisory Committee of the Joint Commission, and on the Board of Governors of the National Patient Safety Foundation. She is a current member of the USP Expert Committee on Compounding, and chair of the Subcommittee and Expert Panel on Hazardous Drugs.


