RENUNCIATION OF PHILIPPINE CITIZENSHIP

REQUIREMENTS:

1. Applicant must be 18 years old

Please **present the original documents** and **submit two (2) copies** of the following:

2. Duly accomplished Affidavit of Renunciation of Philippine Citizenship notarized by a Notary Public
3. Philippine passport – original will be cancelled and will be returned to the applicant
4. For those who have retained/re-acquired Philippine citizenship (dual citizens) under R.A. 9225, submit Oath of Allegiance, Identification Certificate and Order of Approval – originals will be cancelled and retained at the Philippine Consulate General
5. Birth Certificate
6. Canadian citizenship certificate or ID / Canada passport
7. For those born in Canada, submit proof of Philippine citizenship of parent/s at the time of birth (e.g. Canadian citizenship certificate, permanent resident, Philippine passport)

NOTE:

- The Consular Officer reserves the right to require additional proof or documents from an applicant to prove his/her citizenship, status or identity pursuant to the Philippine Passport Law (RA 8239) and the Foreign Service Act (RA 7157).
- **Applicants submitting by mail should provide their contact details (e.g. phone/mobile number or e-mail address) and a self-addressed registered and prepaid envelope.**
- **Certification fee: 33.75 CAD** in cash or money order/bank draft made payable to the Philippine Consulate General. Do not send cash in the mail;
