## Naval Aviation Small Business Roundtable Security Clearance Survey Results

The Naval Aviation Small Business Roundtable (SBRT) conducted a survey of members to assess the impact of the current state of security clearance processing in our community. All SBRT members were emailed to announce the purpose of the survey and how to participate. The survey was available to members through our website from 28 August through 8 September 2017.

The SBRT worked with NAVAIR to determine the content of the survey. The following four (4) questions were posed to our membership:

- 1. How long does it take DSS to acknowledge pick-up of clearances submitted in the JPAS system?
- 2. What is the average timeframe to obtain an interim SECRET clearance?
- 3. What is the average timeframe to obtain a SECRET clearance?
- 4. How many individuals, on average, does your company have idling in anticipation of a clearance?

We received a total of twenty-one (21) survey responses from our membership of 136 organizations. Respondents used different units of measure (e.g., hours, days, months, years) for questions 1 through 3, so all response times were converted to days. Most respondents provided a range when answering each question. The survey results from all respondents are provided in Table 1.

Some respondents offered additional insight within their reply to each survey question. The survey question related to individuals idling in anticipation of a clearance generated the most feedback. Below are those responses.

- ➤ "Not big enough to carry idling personnel in anticipation of a clearance."
- > "Due to the clearance processing delays, the company couldn't afford to wait for individuals to clear. All candidates had to already have a clearance for us to start the recruiting process."
- We typically do not have people idling on the sidelines waiting for their clearance as our Overhead costs cannot cover them. Therefore, we have been losing candidates waiting for the clearance process. Furthermore, this has increased the salary demands of young professionals with 1 and 2 years of experience because they know they can get more once they have the clearance. This then increases the salary demands of more experienced professionals as well. There is nothing filling the Junior levels since clearances are taking so long to obtain. We have seen salaries increase across the board about 5% to 10% from our cleared professionals trying to retain them since backfilling them with younger talent is hard to do when it takes so long to obtain a clearance."

Security clearance processing times, in days, reported by the National Industrial Security Program Policy Advisory Committee (NISPPAC) on May 10, 2017 are provided in Table 4.

The results of the SBRT survey indicate many of our respondents obtain interim secret clearances within the 129-day timeline and have similar results for receiving the final adjudication by the 288-day timeline reported by the NISPPAC.
