Incorporation of Association Compliance

To comply with the rules of an Incorporated Association, all NEW members, are required to **complete the Application for Membership of Association form overleaf, sign and return it, with applicable Membership fees for the period nominated by you, in the Return Address Envelope provided.**

FULL & LIFE Membership of the 450 Squadron RAAF Association Inc. entitles you to be nominated for a position on the Committee and to vote at the Annual General Meeting (AGM) of the Association, held in **APRIL** of each year, *or otherwise approved extended date should the members be unable to form the necessary quorum required to hold an AGM.*

ALL Members are entitled to receive a free copy of the Harasser Newsletter; attend official events, *including the AGM* and assist in fund raising.

Upon receipt of your application and payment for Membership of Association you will be forwarded a Membership Card for the period nominated, and a receipt for Membership payment.

Unique Membership numbers for FULL Membership will be made up of the original RAAF ID number of the 450 Squadron member to whom you are related, followed by a code identifying your relationship to that member.

e.g. If Joe Smith was my grandfather (member of No. 450 Squadron) and his RAAF ID number was 123456, my Membership number would be 123456-GD – the suffix GD indicating my relationship, to Joe as his granddaughter.
