1. Meeting was promptly called to order at 6:35 pm by Mr. Thomas.

2. Review/ Approve meeting minutes

A motion was made and Selectmen voted 3-0 to approve August 16th, 2016 meeting minutes and August 30th warrant.

3. John Viet

John explained at the meeting by the 1st of November he will be moving the mobile home that exists on his property as a second residence. He explained that the CEO came to his house twice, both times that were not convenient. John explained his plan was to sell the house in the Spring and the bank will not finance with the mobile home on the property. He has to wait for housing availability for his daughter before he can move the mobile home. The Selectmen requested John to write a letter explaining his plan, sign it and send it to the Selectmen's office. The Selectmen explained they just need to understand John's plan moving forward.

4. Steve Estes

Steve explained last Thursday on August 25th, Denis Berube showed up at Estes to review his pit. He further explained that his pit is under MSHAW (Mine Safety and Health Administration) regulations and legally nobody can enter his pit without his supervision. Bob Flint reviewed property cards that Denis Berube provided that detailed the gravel pits in town. Two property cards have gravel pit line items giving a value for their pits, and two property cards that did not; one including Estes. Flint explained that the Selectboard is just doing their due diligence and everyone should be treated the same. They asked Denis Berube to look at the gravel pits and make sure they are all being assessed using the same assessment process. There was discussion regarding if a pit can be taxed as a business? Also that the personal property tax list should be re-assessed and made sure is current. Steve Estes also brought up that there was an error in the TRC Maietta report and that he was listed as the owner of Maietta. He tried calling TRC, but there was no response. He explained that it needs to be corrected. The Selectmen will contact TRC, removed the report from the website and will request a corrected version of the report.
