Motion by Lamb with a second by Rollin to approve the minutes of the regular scheduled May 17, 2021 meeting as written. Roll call: three yeas. Checks 9522-9549 and payments totaling \$38,348.96 approved for payment.

Motion by Lamb with a second by Rollin approve the May Financial report with year to date revenue \$253,123.77, year to date expenditures \$133,608.54 and bank balances of \$427,101.14. Roll call: three yeas.

Motion by Holmes with a second by Lamb to authorize *Resolution 2021-38* an MOU for the storm water grant to fix culvert #631 on Stewart Road. Roll call: three yeas.
