Awards of Merit shall be awarded to dogs and bitches other than the Best of Breed and Best Opposite Sex winners. The AOM criteria is as follows:

5 Champions – 1 AOM	15 Champions – 3 AOM
10 Champions – 2 AOM	20 Champions – 4 AOM
