**Over a decade ago,** one of our long-time members created an endowment at the Community Foundation of the Florida Keys (CFFK) to benefit One Island Family. The terms of the endowment are that once per year, One Island Family will receive a pay-out from the invested principle of that generous gift. There have been years when that pay-out was sorely needed! It's comforting to know that every November we have that automatic infusion of operating cash. If One Island Family should cease to exist, the balance of the endowment would revert to CFFK ownership.

The CFFK endowment allows *anyone* to <u>add</u> to the existing principal! This has happened in the past. The purpose of this note is to remind everyone of this opportunity. I'm a past Board member of CFFK, and if you would be interested in this gifting strategy, please contact me and we can make this happen. Aside from the tax advantages to the donor, the additional benefits are excellent:

- (1) It benefits CFFK to have this fund (and many others) in their portfolio. This is where charitable people go to see how Key West is investing in itself, and where the needs are.
- (2) It benefits One Island Family by virtue of the once-per-year unrestricted grant.
- (3) And here's the real <u>magic!</u> The OIF pay-out percentage is calculated so that the endowment principal <u>never</u> runs out!! Your gift is not just for that calendar year ... it becomes a part of the annual OIF pay-out, FOREVER!
