NEW WELL DEVELOPMENT PROJECT**

Separate sealed Bids for the construction of the **New Well Development Project** will be received by J. Jeff Kilgore, Director, at the Woodway Water Authority Administrative Offices, 133 Ben Lawson Drive, Pennington Gap, Virginia 24277 until **2:00 p.m.** local time on **Thursday, March 21, 2019** at which time the Bids received will be **publicly opened and read aloud**.

The Projects consists of two (2) separate Divisions:

Division No.1 is the construction of a new well water treatment plant including all site work, piping, electrical, concrete, masonry, waterline, finished water pumps, contact tank, and associated work.

Division No.2 is the construction of a new intermediate pump station including all site work, piping, electrical, concrete, waterline, water pumps and associated work.

Bids will be received for a single prime Contract. Bids shall be on a lump sum basis. The Project is funded through the **Virginia Department of Health**.

Bidders must comply with the following: the President's Executive Order # 11246 prohibiting discrimination in employment regarding race, color, creed, sex, or national origin; the President's Executive Orders # 12138 and 11625 regarding utilization of MBE/WBE firms; the Civil Rights Act of 1964, the Davis-Bacon Act; and Section 436 of P.L. 113-76 American Iron and Steel. Bidders must certify that they do not or will not maintain or provide for their employees any facilities that are segregated on the basis of race, color, creed, or national origin.
