TERMS OF CONTRACT AND DESCRIPTION OF SERVICES TO BE PERFORMED

SPRING CLEAN UP: Cemetery, Township Hall and Park

- Must be completed by May 1st
- Removal of all natural and unnatural debris from grass areas, ditches, driveways, sidewalks and parking lots. (Example: artificial flowers, loose trash, sticks, leaves, etc.)
- Company/Individual must remove and dispose of natural or unnatural debris. Debris may not be disposed of or burned on Township property.
- Company/Individual must provide equipment used to perform services including removal or disposal of debris
- Company/Individual is responsible to any damages that occur while services are performed, unless advised by Township Supervisor

FALL CLEAN UP: Cemetery, Township Hall and Park

- Must be completed by November 15th
- Removal of all natural and unnatural debris from grass areas, ditches, driveways, sidewalks and parking lots. (Example: artificial flowers, loose trash, sticks, leaves, etc.)
- Company/Individual must remove and dispose of natural or unnatural debris. Debris may not be disposed of or burned on Township property.

- Company/Individual must provide equipment used to perform services including removal or disposal of debris
- Company/Individual is responsible to any damages that occur while services are performed, unless advised by Township Supervisor

MOWING AND TRIMMING: Cemetery, Township Hall and Park

- Mowing and trimming must be done weekly, unless the Supervisor advises otherwise. (Example: dry spells)
- Trimming includes around headstones, shrubs, buildings, playground equipment and trees. Anywhere there is grass that can't be mowed.
- Mowing and trimming includes all grass areas up to roadway edges and township property lines.
- Mowing includes the outfield of the ball diamond at the park, but not the infield.
- Grass clippings are to be blown from the driveways, sidewalks and parking lots.
- Company/Individual must provide equipment used to perform the above services
- Company/Individual is responsible to any damages that occur while services are performed, unless advised by Township Supervisor

ROUND UP: Cemetery, Park and Township Hall

- Apply Round-up around fencing and landscaping as needed and advised by Supervisor Company/Individual must provide equipment used to perform the above services
- Company/Individual is responsible to any damages that occur while service are performed, unless advised by Township Supervisor
