We cannot obtain the DHEC permit for opening the pool until after DHEC have inspected the bathrooms. If we cannot open for Memorial Day weekend, we will let everyone know.

The annual dues were due for payment at the end of March, so if you have not paid already you are overdue. Please remember that liens will be issued for unpaid assessments on May 16th and access cards (or fobs) for the facilities will be suspended for anyone with a balance on their account. If your access to the facilities is suspended, it will take up to one week to have it enabled and you will not be granted access to the facilities until the card is re-activated. The management company handle the access cards and they only activate cards once a week (Thursday). So if you have not already paid, please do not leave it until the last minute.

TRAFFIC & PARKING ISSUES:

Recently the issues of speeding, stop sign running, and parking in the neighborhood has been a concern among many homeowners. Opposite are the City of Mauldin's Codes and Ordinances concerning parking. If you are in violation of any of the codes, please remember this is not an HOA issue, but a Mauldin City Law that you are breaking. The streets in Planter's Row are owned and maintained by the City of Mauldin and you may receive a ticket.

FACILITIES/LANDSCAPING REPORT:

The clubhouse development has finally started and we hope to see it completed by the summer. We will also continue the soccer field development. We have replaced the kiddie pool pump and the motor on the main pool. We will also be installing a new security system in the clubhouse and the common area. New safety mulch will be placed in the playground area. The tennis court will have new wind screening and the canopies will be repaired. The bathrooms are being completely rebuilt to ADA standards, with two stalls in the women's and an ADA stall and urinal in the men's. We are also considering the purchase of a drink vending machine. This year the main pool will be emptied, inspected for any damage, cleaned, and refilled.

Mulch will be put out in the amenities area and at all of the entrances to the neighborhood. We are still trying to work out the electrical problems with the monuments, so at the moment we will not be planting any additional flowers. Please remember the area is still a construction site, so we ask that you use extreme caution when walking from the parking lot to the tennis court or playground area.

RECREATION/CLUBHOUSE COMMITTEE:

The recreation and clubhouse committee are currently busy selecting the interior colors and equipment, as well as making the rules and regulations for renting and using the clubhouse. ENFORCEMENT ISSUES:

Remember as we enter the warmer months, the covenants require homes and yards in Planter's Row to be maintained to a satisfactory level. This includes taking care of things like mailboxes, flower beds, vinyl siding etc. One of the biggest problems we are still facing is homeowners that are parking on the grass. Be warned if you continue to park on the grass, you will be fined. The neighborhood has a professional power washer that is available for rental. The fee is \$50 for a two day period. CHAPTER 38 - TRAFFIC AND VEHICLES.

Sec. 38-81. Obstructing Roadways.

(a) No person shall stop, stand or park any vehicle upon a street, other than an alley, in such a manner or under such conditions as to leave available less than ten feet of the width of the roadway for free movement of vehicular traffic; except, that a driver may stop temporarily during the actual loading or unloading of passengers or when necessary in obedience to traffic regulations or traffic signs or signals of a police officer.

Sec. 38-86. Prohibited in Specified Places.

(a) It shall be unlawful for the operator of any vehicle to stop, stand or park such vehicle in any of the following places, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer or official traffic control sign or signal:

(1) On a sidewalk.

(2) In front of a public driveway or so near thereto as to interfere with the unobstructed use of such driveway.

- (3) Within an intersection.
- (4) Within 15 feet of a fire hydrant.

(7) Within 30 feet upon the approach to any flashing beacon, stop sign or traffic control signal located on the side of a roadway.

Please remember there is a \$10 charge for any pool party/pavilion rentals. Full details are on the reservation form.

These regulations are mandated by DHEC for the entire state of South Carolina. Violations of these regulations can cause pool closure and/or fines as dictated by DHEC

- No solo swimming and no diving.
- No running, pushing, boisterous or rough play in the pool, pool deck or cabana area. •
- No person under the influence of drugs or alcohol should use the pool.
- No spitting or blowing nose in the pool. .
- Persons with diarrheal illness or nausea should not enter the pool. •
- Persons with skin, eye, ear, respiratory infections or communicable diseases should not enter the pool. .
- Persons with open lesions or wounds should not enter the pool.
- No animals or pets allowed in the pool or pool area (except service animals). •
- No glass or dangerous objects shall be brought into the pool, pool deck or cabana area.
- No children should be in the pool without supervision. •
- You should take a shower before entering the pool.

In addition to the above DHEC mandated regulations, Planter's Row has added these health and safety regulations. No Smoking in pool, pool deck or cabana area. (A designated smoking area has been established outside the pool area near the bike rack). Vaping is permitted on the pool deck. No riding skateboards, bikes or scooters in the cabana or on the pool deck. Alcoholic beverages should be out of public view concealed by a koozie (no glass containers allowed).

- No profanity in the pool or cabana area.
- Anyone entering the pool must have proper and acceptable swimwear. (Please remember we are a family friendly facility and we ask that you dress accordingly) Public displays of affection are not welcome in our family friendly facility.
- During electrical storms, the pool must be evacuated as directed by the lifeguard staff. •
- For safety reasons, no person under the age of 14 should be left unsupervised in the pool or pool area.
