## “NEW MTO INSPECTION STANDARDS”

The ATSSA is conducting an impact review of the amendments made by the MTO to three regulations (611,601 & 199/07) under the HTA to harmonize with the NSC Standards, effective as of Jan.1, 2015- Operators and Inspection Stations.
