#### A. PASSPORT APPLICATIONS/RENEWALS

- Applicants must refer to the list of requirements on page 3 of the e-passport application form.



#### B. REACQUISITION OF PHILIPPINE CITIZENSHIP (RA 9225)

- Application form/requirements **MUST** be submitted to the Philippine Consulate General in Vancouver **on or before 13 September 2019** for evaluation. Note that applicable fees (in money order/bank draft) must be submitted with your application.

#### C. ACKNOWLEDGMENT/NOTARIALS/AUTHENTICATION, REPORTS OF BIRTH/MARRIAGE/DEATH, NBI

- No need to book an appointment.
- Applicants must submit a prepaid return envelope (Xpresspost) for the release of their documents.
- Xpresspost envelope is not required for NBI applicants.
