Village of Dryden MCL 123.165 Water/Sewer Affidavit

Instructions:

1. Notice to Property Owners or Landlords:

If you are a property owner (the person whose name appears on the latest tax assessment roll) of rental property and desire, pursuant to MCL123.165, to avoid a tenant's (any person, business or organization that rents or leases a property) unpaid water/sewer bill from becoming a lien against your real estate, you may execute the following affidavit and file it with the Village of Dryden Water/Sewer Billing Department, 5602 Main Street, Dryden, MI 48428, together with a deposit of \$225.00, or such other amount as may be established by the Village of Dryden Council. Use the attached form of affidavit only. Do not use your own affidavit.

- 2. Requirements & Contents of Affidavit:
 - A. The written lease with tenant; said lease must specifically provide that the tenant, not the owner of the property, is directly responsible for all water and sewer bills associated with the unit under lease to that tenant.
 - B. The Affidavit must be filled in completely, accurately, signed and notarized. If it is not correctly and completely filled out, signed and notarized, any benefits allowed pursuant to MCL 123.165 will not be available to the property owner.
 - C. If there is more than one property owner or tenant; said Affidavit must provide all applicable names. All required data must provide for said Affidavit to be valid and enforceable.
 - D. The Affidavit must contain the exact date upon which the tenant's written lease terminates. If the lease is extended, the extension must be in writing and the new termination date provided to the Village with an Affidavit containing the new information.
 - E. The \$225.00 deposit required of said tenant must have been paid

3. Information Regarding Tenants Water/Sewer Bills:

A property owner may obtain information from the Village with respect to the status of any tenant unpaid water bill if said tenant signs a "Release of Information" and return said form to the Village of Dryden.
