PRESENT

The School Board of Ridgeview Global Studies Academy, Inc met at 6:00 P.M., Monday, October 25, 2021 in the Ridgeview Academy Secondary's Cafeteria. CALL TO ORDER

The meeting was called to order at 6:08 P.M. Minutes from the August 23, 2021 board meeting were shared with the Board Members and a motion to accept the minutes was made by Sybille Oldham Jackson and seconded by Tim Alterio. A unanimous vote was taken.

NEW BUSINESS

Mr. Johnson shared with the board the COVID requirements have not changed much only with exception that parents have to sign a letter for the student to return if they were sent home to quarantine but are asymptomatic.

He also shared data with the number of cases in our school. We have 20 elementary students and 5 secondary that have tested positive. Also, we have four staff members that have tested positive.

School Grade Incentive was discussed, and a motion was made by Sybille Oldham Jackson and seconded by Tim Alterio to give the staff a \$1000.00 bonus. It was decided that \$500.00 would be given before Christmas and the other \$500.00 would be given the end of the year. Bonuses for part time staff members would be prorated accordingly. A unanimous vote was taken.
