4. We are required by the state to collect 6% sales tax.

Sunday, Jan 20th: Vendor Access 6 am, Public Access 8 am to 3 pm

Vendor Spaces: Land Spaces -10' across x 20' deep for merchandise, Boat Spaces - 15' x 25'.

All merchandise, trailers, vehicles, etc. **must fit** within your allotted space. If for any reason your "stuff" does not fit within your space you will be required to purchase additional spaces. Due to the layout of the park & its curved walkways, spaces may not be "square" and may be adjacent to another vendor. Please view the vendor map located on the Event's Website (www.nauticalfleamarket.com).

Security: Law Enforcement Detail will be on site (including overnight) beginning Friday, January 18th until Sunday, January 20th.

Rules and Regulations:

1. Only those products directly related to the design, construction, repair, maintenance and/or use of recreational boats and the marine industry shall be displayed by Vendor. Vendor shall remove items and/or displays not in compliance with this application.
2. Electricity, water and telephone services are not available within the Nautical Flea Market. Due to fire regulations, generators are not permitted (inverters are ok).
3. **RELEASE & INDEMNIFICATION AGREEMENT:** The undersigned in consideration of the Nautical Flea Market and the Cities of Pompano Beach and Lighthouse Point providing us with space for sale of our various nautical goods, and other valuable consideration, do hereby release the Nautical Flea Market, the Cities of Pompano Beach and Lighthouse Point, and any other of their members, employees, agents, or volunteers from any liability for the loss or damage of work, personal injuries or property damage. Further in consideration of the above, the undersigned does hold harmless and agree to indemnify the Nautical Flea Market, the Cities of Pompano Beach and Lighthouse Point and any of their members, employees, agents, or volunteers for any damages, attorney fees, or costs for any legal actions resulting from any claim made in which they, their members, employees, agents, or volunteers are made parties defendant. The release and indemnification agreement applies for the duration of the Nautical Flea Market scheduled for the 18th through the 20th day of January 2019, and to any claims made within the application statute of limitations for loss occurring during that period of time.
4. NO pets are permitted in the Nautical Flea Market.
5. Nautical Flea Market Event is a rain or shine event. No refunds will be given.
6. Clean Up: Vendor is obligated to clean up their allocated space and removed any and all articles placed on the ground, waste products, merchandise and debris from such area. No holes may be made in the asphalt for tent

poles. Oil and fuel containers must be disposed of properly. No pressure cleaning is permitted. **Vendors must vacate space by 6 pm on Sunday, January 20th.** Event Committee reserves the right to charge a cleaning fee to vendors that do not comply.

7. No food or beverages may be sold without prior written consent by the Event Committee.

Vehicles/Parking: Vendor shall be permitted to park only sales and/or storage vehicles within their allocated vendor space during the term of the event. Vehicles brought in on Friday for Load In and parked within the Event Site will not be allowed to leave until gates are opened on Sunday, January 20th at 3 pm. All other vehicles owned by Vendor, its employees, etc. shall be parked in the designated vendor parking areas in order to provide unobstructed driveways for emergency vehicles.

You can walk to your booth anytime on Friday from 7 am to 5 pm; or from 6 am on Saturday and Sunday. No vehicles are allowed after 5 pm on Friday as the Fire Department locks the gates.*
